7. <u>BACKGROUND</u> :						

On August 14, 2001, the Board of County Commissioners approved an interlocal agreement with the City of Bonita Springs regarding cost sharing in the Bonita Beach Renourishment project based on the Florida Department of Environmental Protection Grant 01LE1. With the hiring of a design professional, the City of Bonita Springs has put on deposit with the Clerk of Courts of Lee County sufficient funds to defray their portion of these costs. The deposit triggered the requirement for separate fund accounting in accordance with the agreement and the actions indicated above will allow for more accurate tracking of project revenues and expenses. With the creation of the subfund, the original revenue budget of \$737,006 can be deleted to avoid overstatement.
