On March 28, 2000, the University Landscaping Capital Municipal Services Benefit Unit (MSBU) was created, as required by the University Overlay Agreement, for the purpose of installing irrigation and landscaping in the medians of Ben Hill Griffin Parkway (BHG) and on Corkscrew Road from BHG to I75. The University Overlay area on Alico Road from BHG to I75 will be completed after the widening of that roadway.

Since the unit was created, the Advisory Committee (members from Alico, Miromar, Grandezza, US Homes, and SunTrust Bank) reviewed, modified, and approved the landscaping and irrigation plans. Lee County's DOT has identified and tagged the specified trees for the project, Lodge Construction was contracted as the construction manager, the water use permit was obtained from South Florida Water Management, and the State permitted the landscaping within their jurisdiction. Lodge Construction recently finished their bidding process to identify the landscaping capital, landscaping maintenance, and the electrical contractors. SECTION 1. CREATION OF UNIVERSITY LANDSCAPING CAPITAL MUNICIPAL SERVICE BENEFIT UNIT. There is hereby created and established the UNIVERSITY LANDSCAPING CAPITAL MUNICIPAL SERVICE BENEFIT UNIT (the "Unit") under the authority of Section 125.01, Florida Statutes, and pursuant to the provisions of the Ordinance. The Unit shall consist of all real property in the unincorporated area of Lee County, Florida outlined on Exhibit C attached hereto.

SECTION 2. PURPOSE FOR CREATION OF UNIT. The Unit is created for the principal purpose of acquiring, constructing or otherwise providing and maintaining various essential municipal services, facilities and improvements within the Unit.

SECTION 3. THE PROJECT. The Board hereby determines that the Landscaping improvements (the "Project"), within the boundaries of said Unit is in the best interests of the County and the property owners in the Unit. The estimated Cost (as such term is defined in the Ordinance) of the Project is not to exceed \$2,000,000. The Board hereby finds that the formation and completion of the Project within the Unit is an improvement which will primarily benefit those lots and parcels of property within the Unit in a manner that is in addition to or different from the benefit that the general public will enjoy. The Cost of the project shall be assessed in accordance with the terms of the Ordinance.

SECTION 4. PROPOSED METHOD OF ASSESSMENT. The proposed method of assessment to be made upon benefited property within the Unit is by front footage. Each lot or parcel of property within the Unit shall be assessed in proportion to the benefit the lot or parcel derives from the Project.

SECTION 5. INTEREST RATE AND TERMS OF SPECIAL ASSESSMENTS. The interest rate on the special assessments levied and imposed in regard to the Project shall be one percent greater than the interest rate the County is able to borrow at time of financing. No prepayments of special assessments shall be accepted prior to adoption of the final resolution confirming the preliminary assessment roll. Upon adoption of such confirming resolution, special assessments may be prepaid in full, without interest, other than interest included as a Cost of the related improvement, at the office of MSTBU Services within 30 days of adoption of such confirming resolution. Thereafter, all special assessments shall be payable in three (3) equal annual principal installments with interest at the above described rate, subject to the provision of Section 4 of the Ordinance, accruing from the expiration of such 30 day period. Each installment, with accrued interest, will be collected pursuant to the Uniform Assessment Collection Act.

SECTION 6. POWERS. For the purpose of providing the services within the Unit, describing in this Resolution, the County shall have all the authority and powers provided in the Ordinance and Chapter 125, Florida Statutes. Should a parcel as described in the legal description attached hereto be subdivided, the assessment will remain with the parent parcel, unless the MSTBU Coordinator is notified prior to the subdivision. Upon notification the MSTBU may reallocate any remaining assessment due among parcels involved in the subdivision.

SECTION 7. EFFECT OF ADOPTION OF RESOLUTION. The adoption of this Resolution will be the final adjudication of the issues presented hereby unless proper steps shall be initiated in a court of competent jurisdiction to secure relief within 20 days from the date of adoption of this Resolution.

SECTION 8. EFFECTIVE DATE. This Resolution shall take effect immediately upon its adoption.


