Approval is required for this Change Order No. 2 under CN-00-03 Summerlin Road Six-Laning with Agnoli, Barber & Brundage, Inc, Contract #1481 for additional design services in the not-to-exceed amount of \$442,828.00.

The design fee negotiated for these services is competitive with other similar projects we have negotiated recently and in line with industry standards.

SECTION 1.00 CHANGE(S) TO PROFESSIONAL SERVICES

The "Scope of Professional Services" as set forth in Exhibit "A" of the Professional Services Agreement, or Service Provider Agreement, referred to hereinbefore is hereby supplemented, changed or authorized, so that the CONSULTANT or SERVICE PROVIDER, shall provide and perform the following professional services, tasks, or work as a supplement to, change to, or authorized to, the scope of services previously agreed to and authorized:

Task 2.03 - Additional Survey for Extended Project Limits

- a) The Consultant shall provide additional engineering and land surveys necessary to extend the project limits approximately 500 feet north of the Summerlin Road/Boy Scout Drive intersection and east, 500 feet along Boy Scout Drive from the Summerlin Road intersection. The additional survey is required due to the additional lane width and the reconfiguration of the typical section which will require modifications to the Summerlin Road/Boy Scout Drive intersection and it's approaches.
- b) The Consultant shall provide additional planimetric survey for a width of 300 feet either side of the centerline along the extended limits as described in 2.01 above.

Task 6.08 - Feasibility Studies for Traffic Signal at Summerlin Commons Way The Consultant shall provide additional placement of traffic signals at Summerlin Commons Way versus Horizon Way.

Task 7.00 - Roadway and Overpass Plans

The Consultant shall develop a revised Bridge Development Report for a concrete bridge vs. a steel bridge for the proposed interchange at Summerlin Road and College Parkway.

Task 7.03 - Detail Plans (90%) - Revise at Grade Roadway Plans

The Consultant shall modify the roadway and overpass plans to accommodate widening of the proposed pavement in the typical section by 4 feet and additional sidewalks.

The current plans and CAD drawing files shall be modified as follows:

- a) Cover Sheet (Sheet 1) Revise station equations for new alignment stationing.
- b) Revise Drainage Maps (Sheets 4, 5, and 6) to reflect grading changes and extended project limits.
- c) Revise Typical Sections (Sheets 7, 8, 9, and 10) to reflect additional pavement, sidewalks, and bike path additions.

- d) Revise Concrete Box Culvert Data Sheets (Sheets 11 and 12) to accommodate the wider Typical Section.
- e) Revise Layout Sheets (Sheets 13, 14, and 15) to reflect revised Station equations and alignment.
- f) Revise Plan and Profile Sheets (Sheets 16 through 35) to reflect extended project limits, revised Typical Sections and revised alignment, etc.
- g) Revise the Intersection Layout Sheets (Sheets 36 through 50) to reflect the extended project limits, revised Typical Sections, and revised alignment, etc.
- h) Revise Drainage Structure Sheets (Sheets 50 through 68) to reflect the revised Typical Sections.
- i) Revise Detention Pond Layout Sheets (Sheets 69 through 76) to reflect the revised Typical Sections and revised alignments.
- Revise Cross Sections (Sheets 78 through 144) to reflect the revised Typical Sections.
- k) Revise the Final Right-of-Way Maps to reflect the change in width of the roadway due to the revised Typical Section, the extended property limits and the revised alignment.
- Revise the Signing and Pavement Marking Plans (sheets 169 through 174) to reflect the revised typical sections, revised alignments, and extended project limits.
- m) Revise the spread calculations, stormwater pipe configurations and sizing calculations, detention pond configuration, routing calculations and SFWMD ERP application booklet to reflect the revised typical section, extended project limits and revised alignment.

Task 7.03 - Detail Plans (90%) - Revise Overpass Plans

The Consultant shall modify the Overpass Plans to accommodate widening of the proposed pavement in the typical section by 4 feet and additional sidewalks.

The current plans and CAD drawing files shall be modified as follows:

- Key Sheet (Sheet 1): Revise index of roadway plans, begin and end of project, length of project box.
- b) Drainage Map (Sheets 3 and 4): Revise to reflect new alignments, new roadway design, new drainage, new existing roadway profile, new proposed roadway profile, and new drainage profile.
- c) Typical Section (Sheets 6 and 7): Revise to reflect new alignments and new roadway design.

- d) Layout (Sheet 14): Revise to reflect new alignments.
- e) Plan (Sheets 15 through 22 and 25): Revise to reflect new alignments, new roadway design, and new drainage design.
- f) Profile (Sheets 28 through 47); Revise to reflect new existing roadway profile, new proposed roadway profile, and new drainage profile.
- g) Intersection Detail (Sheets 53 and 54): Revise to reflect new alignments and new roadway design.
- h) Grading Detail (Sheet 55): Revise to reflect new alignments, new roadway design, and new grading.
- i) Intersection/Grading Detail (Sheet 56): Revise to reflect new alignments, new roadway design and new grading.
- j) Drainage Structures (Sheets 57 through 85): Revise to reflect new alignments, new roadway design, and new drainage design.
- k) Cross Sections (Sheets 95 through 129): Revise to reflect new alignments and new roadway design.
- Traffic Control Plan Typical Sections (Sheets 150 and 151): Revise to reflect new alignment and new roadway design.
- m) Utility Adjustment (Sheet 152 through 159 and 161 and 162): Revise to reflect new alignments, new roadway design, and new drainage design.
- n) Utility Adjustment Profile (Sheets 165 through 184): Revise to reflect new existing roadway profile, new proposed roadway profile, and new drainage profile.
- o) Revise the Signing and Pavement Marking Plans (Sheets S-4 through S-11 and S-14) to reflect new alignments and new roadway design.
- p) Revise the spread calculations, stormwater pipe configurations and sizing calculations, and SFWMD ERP application booklet to reflect the revised Typical Section and revised alignment.

Task 7.04 - Summerlin Commons Way/Horizon Way Interconnect

The Consultant shall provide engineering, land and planimetric surveys, and Construction Plans for a roadway interconnection between Summerlin Commons Way and Horizon Way.

The current Plans and CAD drawing files shall be modified as follows:

- a) Revise Drainage Maps to include drainage details for the interconnect.
- b) Revise typical section sheets to include the interconnect typical section.
- c) Add additional plan and profile sheets for the proposed interconnect.

- d) Add additional drainage structure sheets for the proposed interconnect.
- e) Add additional cross section sheets for the proposed interconnect.
- f) Add additional signing and pavement marking plans for the proposed interconnect.
- g) Add additional right-of-way maps to cover the proposed interconnect.
- h) Revise the drainage calculations and ERP permit application to cover the proposed interconnect.

Task 9.05 - Right-of-Way Parcel Boundary Surveys

The Consultant shall provide two (2) copies of Certified Boundary Surveys of each parent tract, acquisition parcel and remainder parcel in lieu of Legal Descriptions and Parcel Sketches.

Task 10.03 - Revise Signalization and Street Lighting Plans

The Consultant shall revise the Signalization and Street Lighting Plans to accommodate the widening of the proposed pavement in the typical section by 4 feet and additional sidewalks.

The current Plans and CAD drawing files should be modified as follows:

- a) Prepare signal modification plans for the intersection of Summerlin Road/Boy Scout Drive. Reconfiguration of the intersection cross section will require signal head re-alignment and detection zones will need to be modified. Pedestrian features will be designed and incorporated into the design.
- b) Prepare signalization plans for Horizon Way. The design of Horizon Way was previously in our scope, but Maple Drive was designed in lieu of Horizon Way at the direction of staff. A signal design for Horizon Way will be completed to service the exiting vehicles from the medical offices and the OJ property.
- c) Design pan/zoom/tilt cameras at three locations along the corridor. Traffic monitoring sites will include Summerlin at Cypress Lake Drive, at Summerlin Road between Horizon and the OJ property access drive and at Summerlin and Boy Scout Drive. All supplement equipment and wiring will be incorporated into the traffic monitoring site's designs. Additional cameras will be installed on the bridge deck were feasible.
- d) The interconnect plan will be modified to include more fiber communications. High capacity multiple strand fiber optic cable will be specified as part of the interconnect design plans from Cypress Lake Drive to Boy Scout Drive along Summerlin Road. Additional fiber optic cable slack will be provided in pull boxes at strategic points for added flexibility for future connection to the proposed Advanced Transportation Management System (ATMS).
- Modify street lighting plans to accommodate future cross section.
 Pole location and conduit placement will be revised to accommodate the shift of the curb line.

f) Modify existing signal plans (four intersections). Existing signal plans will be revised to incorporate new roadway cross section. Signal pole placement will be adjusted to avoid new sidewalk and new edge of pavement. Signal pole design will be adjusted to accommodate new geometries and span lengths.

Task 10.04 - Provide plans for pavement embedded SMARTSTUDS.

The Consultant shall provide Lighting Plans for the SMARTSTUD system containing the following:

- a) Key Sheet (Sheet 1)
- b) General Notes (Sheet 2)
- c) Electrical Riser Diagram (Sheet 3)
- d) Overpass Lighting Details (Sheet 4)
- e) Service Point Details (Sheet 5)
- f) SMARTSTUD Generator Electrical Schematic (Sheet 6)
