## RE: Additional Building Inspector and Permit Technician Positions

Since the last fiscal year, Building Inspections have increased nearly 20%, from 137,415 to 163,832. This is an increase of 26,417 inspections in a single year. In 1999 the Building Industry Oversight Committee recommended a maximum number of inspections a Building Inspector could adequately perform in a day at 25 inspections. During the months of August, September and October this year, building inspectors approached or exceeded the maximum number over 800 times.

<u>Month</u>	Number of Inspections 25 or over
August September	244 272
October	378

Having to perform this many inspections in a day requires the inspectors to limit the amount of time they can spend on the job site performing the inspection. The quality of the inspection is directly related to the amount of time an inspector has to spend inspecting construction work. The Building Industry Oversight Committee has requested that the inspectors spend the time necessary to perform inspections of adequate quality.

Additionally, the large increase in the amount of permitting has resulted in dramatic increase in the amount of customers in the permit lobby. The number of customers increased 35% over the last fiscal year to over 70,000 customers.

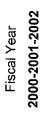

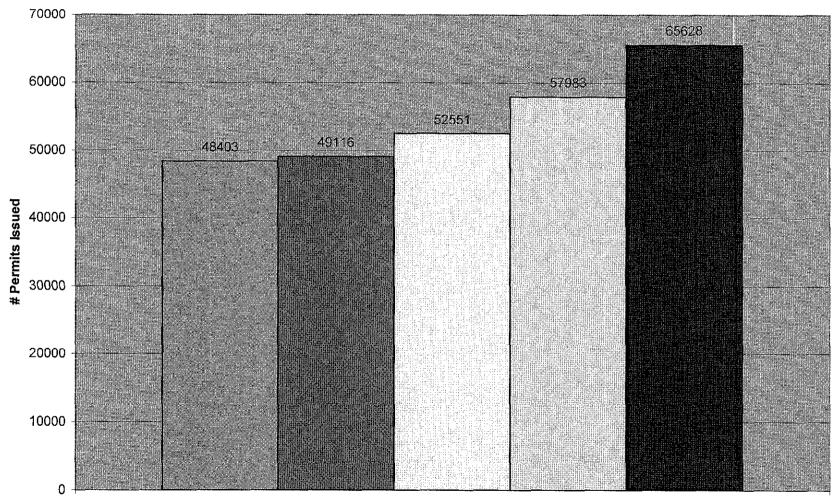

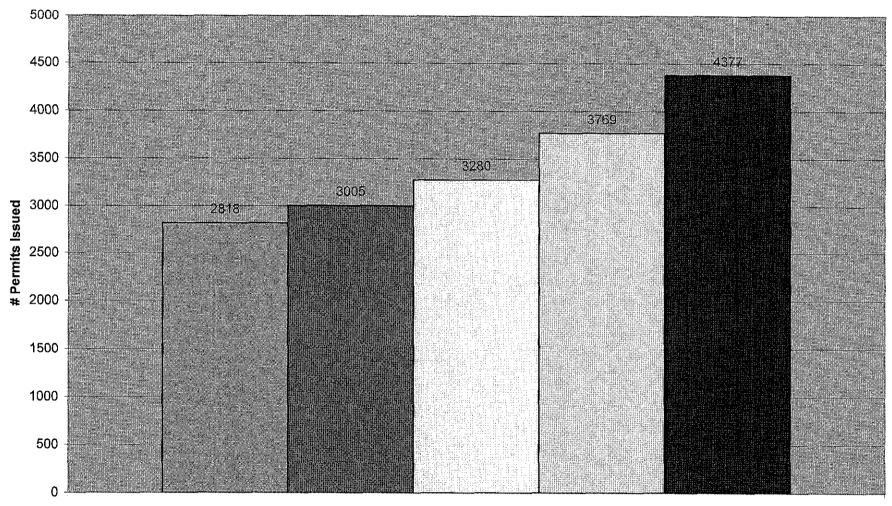


# **Total Permitting**
