The construction documents contemplates a project with a construction budget not to exceed <u>\$649,836.00</u> which budget excludes previously agreed to AE fees.

<u>Period of Construction; Additional Fee</u>. Owner, AE and CM expect and believe that the period of construction or construction phase for the Project shall be \underline{two} (2) months to substantial completion and \underline{three} (3) months to final completion.
