9. Background:

On January 30, 2002, the County engaged the services of the Williams Mullen law firm which established hourly rates for attorneys' services therein at Section 4., <u>Compensation</u>. The firm is now requesting an increase to their discounted rates for their services to the County. The proposed increase is reasonable, given the time that has passed, and the quality and quantity of services that have been provided to the County by the firm for the past three (3) years.

Dear David:

From time-to-time as personnel change, an amendment to the firm's contract with the County needs to be accomplished to add or delete people. My current contract is the one I signed when I changed to this firm about three years ago. As I propose to delete numerous people (as I can't see using them) and adding a few, I would suggest I simply redo and substitute a new Exhibit "A".

Also, the rates for partners (shareholders) is currently \$225.00/hr. My real rate is 400.00/hr and higher overseas. David: I am writing to request a raise in our hourly rates. If you are not comfortable with that or do not want to take this to the Board, I will, of course, continue to perform pursuant to the rates in my current contract. In my experience, law firms generally increase their rates by about 5% a year. My normal rate is \$400.00/hr and higher for overseas projects. However, I do not get those rates for counties and cities I represent in the US. Since my contract is about 3 years old now with Lee County, I would respectfully request that my rate and those of members of the firm and of counsel be increased from \$225.00/hr. to \$250.00/hr. and those of associates be increased from \$190.00/hr. to \$200.00/hr. I appreciate your consideration of this request. Thank you.
