9. Background:

Letters of Interest were solicited on behalf of the Board of County Commissioners for professional services for the project known as CN-05-16 Lee County Utilities Office Building.

The deadline for receipt of Letters of Interest was June 24, 2005. A total of ten (10) letters of Interest were received by the established deadline. The Competitive Negotiations Committee consisted of the following staff members: Jim Lavender, Public Works Director, Chairperson, Ayoub Al-Bahou, Project Manager and Ivan Velez, Utilities. On the basis of the information submitted by the ten (10) firms in their Letters of Interest, it was the consensus of the committee to invite four (4) firms for interviews/presentation: Architecture, Inc., Harper Aiken Partners, Inc., Sheeley Architects, Inc. and Song & Associates.

On the basis of the information submitted by the firms in their Letters of Interest and after conducting the interviews/presentations on July 1, 2005, with the "short list" firms, the Committee agreed to recommend to the Board the following order of ranking of Consultants: 1) Sheeley Architects, Inc.; 2) Harper Aiken Partners, Inc.; 3) Architecture, Inc.; 4) Song & Associates.

The negotiated agreement with the number-one ranked firm will be brought back to the Board for their approval.
