9. Background: The Department of Housing and Urban Development (HUD) requires that the County enter into Urban County Agreements with the Cities of Bonita Springs, Sanibel and Ft. Myers Beach. The City of Bonita Springs entered into the Urban County Agreement, County Resolution Number 01-06-43, in June 2001. The City agreed to the timely disbursement of CDBG funds. HUD requires all entitlement jurisdictions to expend the CDBG funds timely. Jurisdictions are not permitted to retain more than 1.5 times their current year entitlement funds. HUD is required to recapture CDBG funding if the jurisdiction is not in compliance. The Urban County Agreement requires that the Cities expend their entitlement funds within 18 months after the entitlement year begins.

Notice was provided to the City of Bonita Springs on June 1, 2005 that the City was not in compliance with the agreement. The City notified staff on July 11, 2005 that the \$10,371 will be utilized for an eligible public infrastructure project.
