9. Background:

In accordance with the Master Transportation System Agreement between Lee County and the City of Bonita Springs, the City is responsible for the final four debt service payments on the Series 2003 Bonds that were issued to pay for the improvements to East Terry Street. This Agreement specifies the City's commitment to make payments to the County not less than three business days prior to October 1, as follows:

FY 05/06 \$290,998.00 FY 06/07 \$291,439.00 FY 07/08 \$290,938.00 FY 08/09 \$290,722.00

Funds will be deposited in the following account: GB5419022561.369900.9041 and placed into Reserves.

RESOLUTION

Amending the Road Improvement Revenue Bonds, Fund 22561, to incorporate the unanticipated receipts into Estimated Revenues and Appropriations for the fiscal year 2004-2005.

WHEREAS, in compliance with Florida Statutes 129.06(2), it is the desire of the Board of County Commissioners of Lee County, Florida, to amend the Road Improvement Revenue Bonds, Fund 22561, for \$290,998 of the unanticipated revenue from reimbursement – City of Bonita Springs, and an appropriation of a like amount for Reserves expenditures and;

WHEREAS, the Road Improvement Revenue Bonds, Fund 22561 shall be amended to include the following amounts which were previously not included.

JOINT SUPPLEMENTAL INTERLOCAL AGREEMENT BETWEEN LEE COUNTY AND THE CITY OF BONITA SPRINGS UNDER ITS MASTER TRANSPORTATION AGREEMENT: EAST TERRY STREET DEBT SERVICE PAYMENTS

WHEREAS, the respective governing bodies for Bonita Springs and Lee County executed a Master Transportation System Agreement dated September 19, 2000, to jointly establish a Five-Year Road Improvement Plan requiring resources of both the County and the City; and

WHEREAS, the Agreement contemplates the use of Supplemental Agreements to the said Master Interlocal Agreement for different stages of road work in Bonita Springs, the first being the Livingston/Imperial connection, four-lane extension from Collier County line to Bonita Beach Road; and

WHEREAS, the Second Supplemental Agreement addressed the four laning of Imperial Street as a collector road from Bonita Beach Road to East Terry Street; and

WHEREAS, the Third Supplemental Agreement involved the widening of Bonita Beach Road between Imperial Street and I-75 and resurfacing between Vanderbilt Drive and Imperial Street; and

WHEREAS, the Fourth Supplemental Agreement addressed the construction of the Three Oaks Parkway Extension South from East Terry Street to The Brooks; and

WHEREAS, the Master Transportation System Agreement identified that the COUNTY was using a portion of impact fee revenues collected in the Bonita Springs area prior to incorporation to pay the debt service for a bond that was used to improve East Terry Street (which is now a CITY street), and the CITY agreed to pay the debt service payments beginning in Fiscal Year 2005/2006; and

WHEREAS, the Parties desire to enter into a Fifth Supplemental Agreement to the said Master Transportation System Agreement, to specify the CITY's commitment to pay the debt service for that portion of the Series 1993 Road Improvement Bond (as refinanced in 2003) used to improve East Terry Street, beginning in FY 2005-2006 and for the three (3) remaining years through payoff in FY 2008-2009;

NOW THEREFORE, in consideration of the above premises and other good and other valuable consideration, the receipt of which is hereby acknowledged, and further consideration of the mutual covenants hereinafter contained, it is agreed by the Parties as follows:

1. In order for the COUNTY to make the required debt service payments by October 1st of each year, the CITY agrees to pay Lee County via wire at least three (3) business days prior to the debt service due date of October 1st. of each year to the COUNTY a portion of the debt service due for the COUNTY's Series 2003 Road Improvement Refunding Revenue Bonds, beginning September 27, 2005, in the following amounts by year:

FY 06/07	\$291,439.00
FY 07/08	\$290,938.00
FY 08/09	\$290,722.00

- 2. The COUNTY will be responsible for the balance of debt service payments due on the Series 2003 Road Improvement Refunding Revenue Bonds during those years.
- 3. Neither Lee County nor the City of Bonita Springs will be responsible for any claims, liabilities, lawsuits, or causes of action arising out of the other party, its contractors, agents, or representatives with respect to either party's performance under this agreement.
- 4. This Agreement is Supplemental to the Master Transportation System Agreement referenced above. However, this Agreement constitutes the entire understanding between the parties as to the subject matter, and other than the Master Transportation System Agreement, any previous Agreements on the subject matter of this Agreement, whether written or oral, is superceded by this Agreement to the extent of any conflict.
- 5. This Agreement may be amended only by the concurrence of both parties and executed with the same formalities as this original Agreement.
- 6. All of the remaining terms in the Master Transportation System Agreement dated September 19, 2000, remain as written, and in full force and effect.
