9. Background: The Division of County Lands received a request from Florida Power & Light Company for an easement to install an underground power line from the Bella Terra project to an existing Florida Power & Light Company easement.

The connections are necessary to "loop" the electrical system and provide an additional power service line. The additional power service will also provide a backup connection for the Lee County Utilities well facilities located south of Corkscrew Road.

Recording costs will be paid by Florida Power & Light Company.

EASEMENT

The undersigned, in consideration of the payment of \$1.00 and other good and valuable consideration, the adequacy and receipt of which is hereby acknowledged, grant and give to Florida Power & Light Company, its licensees, agents, successors, and assigns, an easement forever for the construction, operation and maintenance of underground electric utility facilities (including wires, cables, conduits and appurtenant equipment) to be installed from time to time; with the right to reconstruct, improve, add to, enlarge, change the voltage, as well as, the size of and remove such facilities or any of them within an easement feet in width described as follows:

An FPL Company easement more particularly described on EXHIBIT "A", attached hereto and made a part hereof. Said easement prepared by Banks Engineering, Inc., dated 12-9-04.

Together with the right to permit any other person, firm or corporation to attach wires to any facilities hereunder and lay cable and conduit within the easement and to operate the same for communications purposes; the right of ingress and egress to said premises at all times; the right to clear the land and keep it cleared of all trees, undergrowth and other obstructions within the easement area; to trim and cut and keep trimmed and cut all dead, weak, leaning or dangerous trees or limbs outside of the easement area which might interfere with or fall upon the lines or systems of communications or power transmission or distribution; and further grants, to the fullest extent the undersigned has the power to grant, if at all, the rights hereinabove granted on the land heretofore described, over, along, under and across the roads, streets or highways adjoining or through said property.

Florida Power & Light Company will indemnify Lee County, a political subdivision of the State of Florida, against any liability resulting from the permitted uses in this easement. Any damage to the Grantor's property or improvements thereon as the result of Florida Power & Light Company (Grantee), its licensees, agents successors, and assigns will be restored by Florida Power & Light Company to the condition in which it existed before the damage.


