- 1. ACTION REQUESTED/PURPOSE: Adopt resolution to amend Lee County Administrative Code to include a new Code to establish a functional classification of major roadways in Lee County.
- 2. WHAT ACTION ACCOMPLISHES: Lee County Ordinance No. 97-23 requires that amendments to the Lee County Administrative Code be made by resolution of the Board of County Commissioners. The proposed Code would establish a new Administrative Code designed to provide a list that would aid in the programing of improvements, establishment of design criteria, and enforcement of County regulations pertaining to intersection spacing, speed, and setbacks.

9. Background:

Pursuant to Florida Administrative Code 14-97, each local government must determine the functional classification for roadways under its own jurisdiction. Lee Plan Policy 6.1.2. requires the County to adopt an administrative code that includes a functional classification list of County roadways. In addition, Lee Plan Policy 36.1.2. provides that reference to the functional classification of roadways in the Land Development Code will rely on existing or future classification of roads. The functional classification for arterial and collector roads is intended to serve as the reference document when the Land Development Code requires the existing classification of a roadway to govern the application of a code standard.

The proposed amendment to the Lee County Administrative Code would create a functional classification structure for major roadways maintained by Lee County based on existing conditions. In addition, the purpose of the Code is to adopt an existing "Functional Classification List", which sets forth the functional classification of all County-maintained roadways, as well as certain non County-maintained roadways located in unincorporated Lee County. The proposed list identifies the major roadways as arterial, collector, controlled access, and expressway facilities. This List will serve as an aid to the programing of improvements, the establishment of design criteria, and enforcement of County regulations. While it is not the purpose of the existing Functional Classification List to determine the classification of State highways or roadways maintained by other local

governments, it is occasionally necessary to determine the existing functional classification of State highways or city-maintained roadways for purposes of enforcement of County regulations within the jurisdiction of the County.

The proposed Code acknowledges that the Director of the Department of Transportation has the ultimate responsibility for determining the existing functional classification of County-maintained roadways. The Development Services Director has the responsibility of determining the existing functional classification of non County-maintained roadways.

DOT staff will create a map depicting the existing Functional Classification List for informational purposes. The List and the Map will be maintained by DOT with the expectation that both documents will be amended as necessary to reflect interim improvements.

Finally, the Code provides for revisions, including interim revisions to the Functional Classification List in the professional judgment of the Director. The Code provides for private individuals seeking to change the functional classification of a roadway included in the list and provides a process for consideration of the request through an Administrative Determination. It is anticipated that the existing Functional Classification List will be officially updated by the Board of County Commissioners on a periodic basis.

A RESOLUTION OF THE LEE COUNTY BOARD OF COUNTY COMMISSIONERS RELATING TO AMENDMENTS TO THE LEE COUNTY ADMINISTRATIVE CODE AS ADOPTED BY LEE COUNTY ORDINANCE NO. 97-23; PROVIDING FOR APPROVAL OF CERTAIN AMENDMENTS TO THE LEE COUNTY ADMINISTRATIVE CODE (FUNCTIONAL CLASSIFICATION OF ROADWAYS); PROVIDING FOR SEVERABILITY; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Board of County Commissioners is the governing body in and for Lee County, a political subdivision of the State of Florida; and,

WHEREAS, the Board of County Commissioners has previously enacted Lee County Ordinance No. 96-01, creating a charter form of government for Lee County pursuant to Section 125.80, Florida Statutes, and which was approved and ratified by the Electorate of Lee County on November 5, 1996; and,

WHEREAS, the Board of County Commissioners has previously enacted Lee County Ordinance No. 97-23, which adopted the Lee County Administrative Code pursuant to Section 2.2.E. of Ordinance No. 96-01, the Lee County Charter; and,

WHEREAS, Lee County Ordinance No. 97-23 at Section III allows for amendments to the Lee County Administrative Code to be made by Resolution of the Board of County Commissioners at a regularly scheduled Board of County Commissioners' meeting; and,

WHEREAS, certain amendments to the Lee County Administrative Code are now proposed, specifically to include a code establishing the functional classification of roadways. The Board of County Commissioners finds that the proposed addition to the

Lee County Administrative Code is acceptable, serves a public purpose, and is consistent with the terms and conditions of Lee County Ordinance No. 96-01, the Lee County Charter.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS that:

- The above preamble is hereby accepted and approved as true and accurate, and is adopted and incorporated herein as if set out further at length.
- 2. The proposed amendment to the Lee County Administrative Code is to include a new code addressing the functional classification of roadways (attached hereto as Exhibit "A"). The proposed amendment to incorporate these code provisions into the County Administrative Code is approved and is hereby directed to be incorporated into the Lee County Administrative Code as indicated in the amendment(s).
- 3. The provisions of this Resolution are severable, and it is the intention to confer to the whole or any part of this Resolution, the powers herein provided for. If any provision of this Resolution is held unconstitutional by any court of competent jurisdiction, the decision of the court will not affect or impair the remaining provisions of this Resolution. It is hereby declared to be the Board's legislative intent that this Resolution would have been adopted had such an unconstitutional provision not been included herein.
- This Resolution will become effective immediately upon its adoption by the Board of County Commissioners.

I. PURPOSE/SCOPE

- A. Pursuant to the Lee Plan, functional classification is the process by which streets and highways are grouped into classes or systems, according to the character of service they are intended to provide. Lee Plan Policy 6.1.2, Paragraph 12, requires the adoption of an administrative code that includes a functional classification list of County roadways. The list must be relied upon for the purpose of determining compliance with the locational standards set forth in Lee Plan Policy 6.1.2. Lee Plan Policy 36.1.2. provides that the Land Development Code will rely on the existing or future classification of roads. The existing classification of roads will be set forth in the subject administrative code. Future classification s are identified on Lee Plan Map 3.B. (Future Functional Classification Map).
- B. The purpose of this administrative code is to set forth the existing functional classification structure for major roadways maintained by Lee County. In addition, to determine the functional classification of each County-maintained roadway based on existing conditions. This administrative code includes an existing functional classification list determining the functional classification of all County-maintained roadways and certain non County-maintained roadways located in unincorporated Lee County as contemplated in Lee Plan Policies 6.1.2. and 36.1.2. It is the intent that the existing Functional Classification List will be an aid to programming of improvements, establishing design criteria, and the application of the County's land development regulations.

II. POLICY AND PROCEDURE

With the exception of the designation of freeways, expressways and controlled access facilities, the Director of the Department of Transportation will have the ultimate responsibility to determine the existing functional classification of county maintained roadways. The Director of Development Services will have the ultimate responsibility to determine the existing functional classification of non-County maintained roadways.

III. DEFINITIONS

Arterial, Principal – A type of arterial primarily intended to carry large volumes of through traffic for the longest trip demands between urban communities and major activity centers of the region. Access to abutting properties is a secondary function. Interstate highways, State highways, limited access facilities, freeways, expressways and controlled access facilities are examples of principal arterials.

Arterial – A street or highway primarily intended to carry large volumes of through traffic connecting major activity centers to other major traffic generators. Access to abutting properties is a secondary function.

Collector – streets having the primary purpose of collecting traffic from intersecting local streets and distributing this volume to the nearest arterial. A secondary purpose is to carry moderate volumes of through traffic. Access to abutting land uses is a secondary function.

Collector, Major – a type of collector street having the primary purpose of collecting traffic from intersecting local and minor collector streets and distributing this volume to the nearest arterial. A secondary purpose is to carry moderate volumes of through traffic. Access to abutting land uses is a secondary function.

Collector, Minor – a type of collector street having the primary purpose of collecting traffic from intersecting local streets and distributing this volume to the nearest major collector or arterial. As such, a minor collector street provides the linkage from neighborhoods (i.e., local streets) to the arterial system, and provides intra-neighborhood access. Access to abutting land uses is a secondary function.

Controlled Access Facility – An arterial roadway that is the subject of a Board of County Commissioners Resolution specifically designating the road as a controlled access facility and specifying the access points along the roadway corridor.

Expressway – An arterial highway, usually divided, designed for the safe and relatively unimpeded movement of large volumes of through traffic, with full or partial control of access and grade separations at most intersections. Expressways are established by Board of County Commissioner Resolution specifically designating the road as an expressway and specifying the access points along the roadway corridor.

Freeway – A type of limited access facility that is a divided arterial highway designed for the safe unimpeded movement of large volumes of traffic, with full control of access and grade separation at all intersections.

Limited Access Facility – A street or highway especially designed for through traffic. Owners or occupants of abutting land or other persons have no right or easement of access, light, air, or view. The right of access may have been donated by the property owner or purchased by the State or a local government.

Local Street – Streets with the primary function of serving the access needs of adjacent properties. As such, a local street provides the linkage from adjacent land uses to the collector street system. Through volume service is not a function of local streets.

Long Range Plan - Map 3A, the Transportation Plan in the Lee Plan transportation element.

Major roadway - A street or highway with a functional classification as an arterial or major collector.

Posted speed - The regulatory speed limit posted on a traffic control device along a street or highway.

State Highway - Roadways under the jurisdiction of the Florida Department of Transportation.

Traffic Volume – The Average Annual Daily Traffic (AADT) volume as reported in the latest edition of the Lee County Traffic Count Report. If none are available, a calculated AADT based on field measured traffic counts and data in the report.

Through traffic – Traffic on a street or highway driving the entire length of a road segment(s) as part of a trip to an origin or destination.

IV. FUNCTIONAL CLASSIFICATION LIST

Exhibit 1 attached contains the Existing Functional Classification List. The list includes each county maintained roadway determined to be an arterial or collector by the Director of the Department of Transportation and certain non-County maintained roadways determined to be an arterial or collector by the Director of the Department of Development Services. Exhibit 2 is a map which depicts the Existing Functional Classification List for informational purposes. The Existing Functional Classification List and map will be maintained by the Department of Transportation and may be updated, as necessary, to include any interim revisions.

The State Highway system has an established functional classification system set forth in Florida Administrative Code 14-97. Each local government determines functional classification for roadways under its own jurisdiction. It is not the purpose of the Existing Functional Classification List to determine the existing functional classification of State Highways or roadways maintained by other local governments for programming of improvements or establishing design criteria under their jurisdiction. However, it may be necessary to determine the existing functional classification of a State Highway or city maintained roadway for purposes of enforcement of County regulations within the jurisdiction of the county.

V. FUNCTIONAL CLASSIFICATION CRITERIA

Exhibit 2 attached contains a matrix intended as a guideline in the determination of the existing functional classification of a street or highway. Characteristics meeting criteria of both an arterial and collector roadway, a collector and local street, or all roadway types may exist. Functional classification will be determined by the Directors, based on exercising sound engineering judgment, quantitative and qualitative criteria.

Quantitative criteria that may be considered in functional classification includes but is not limited to measurable criteria such as traffic volume, facility or route length, posted speed, traffic signals or stop signs, existing connection separation, side street spacing, and bus routes.

Additional qualitative criteria considered may include but not be limited to, connection of urban communities, long range plan, continuity as part of a longer route, emergency evacuation routes, through traffic, direct residential unit access, penetration of a neighborhood and roadside or on-street parking.

The distinctions between the types of arterials are primarily dependent on operational features and level of access control. The roadway, traffic and signal characteristics of the types of arterials and collectors as defined below are the primary factors in determining the functional classification.

Arterial

Roadway is part of a long travel route, has a high posted speed, traffic signals, greater existing connection separation, greater side street spacing and bus routes. The street is an important part of the long range plan, part of a longer travel route and typically an emergency evacuation route. Mobility of through traffic is the primary function. Most of the traffic volume results from through traffic. There typically are not direct residential accesses. The highway does not penetrate a neighborhood. Driveways often are shared by multiple businesses. The street typically prohibits roadside or on-street parking.

Major collector

A type of collector, usually part of the long range plan, and can be at one end of a longer route containing an arterial. May be, but is typically not, part of an emergency evacuation route. Mobility of through traffic is less than an arterial but is still the primary function. Through traffic volume is typically higher than traffic resulting from direct access, there sometimes are direct residential driveways. The street rarely has roadside or on-street parking. The street may have some characteristics of an arterial.

Collector

Characteristics include a moderate facility length, a moderate posted speed, traffic signals only at intersections with an arterial, moderate existing connection separation and side street spacing. It may have one bus route. The street does not penetrate a neighborhood. Access to property is a secondary function.

Minor Collector

A type of collector with a short facility length, low posted speed, perhaps one traffic signal, minimal existing connection separation, and frequent side streets. The street is not part of the long range plan or an emergency evacuation route. It may be the end of a longer route in a residential neighborhood. Mobility of through traffic is moderate. A significant percentage of traffic volume is through traffic but most of the traffic volume is from direct access, there often are direct residential accesses. The street may have roadside or on-street parking. The street may have some characteristics of a local street.

Local

It has low traffic volume, a short facility length, low posted speed, typically does not have a traffic signal, has minimal existing connection separation, and no bus routes. Is not part of the long range plan, a longer route or an emergency evacuation route. There sometimes are direct residential accesses and the street may have roadside or on-street parking. The street is contained in a neighborhood. Existing roadways that are not classified as a type of arterial or collector are considered a local street.

VI. REVISIONS

The Director with ultimate responsibility for administratively approving interim revisions to the Existing Functional Classification List is set forth in Section II. If, in the professional judgment of the appropriate Director, a road segment belongs in a different classification, that Director may reclassify the segment.

Applicant's seeking to change the functional classification of a roadway on the Existing Functional Classification List County must jointly petition the Directors of the Department of Transportation and Development Services. The petition must be written and set forth the reasoning behind the proposed change based on an engineering analysis of the roadway function including, but not limited to, the guidelines in Section V. The Director(s) will issue a joint written administrative determination within 30 calendar days of receipt of the petition, indicating whether the proposed change is accepted or denied.

The administrative determination will stand until officially amended by the Board of County Commissioners as part of an update of the Existing Functional Classification List.
