- **2. WHAT ACTION ACCOMPLISHES:** Acceptance of the grant award will enable the Lee County Sheriff's Office (LCSO) to hire two (2) detectives for the LCSO Human Trafficking Unit as well as purchase equipment, supplies, travel and training expenses, and contractual services.
- **3. MANAGEMENT RECOMMENDATION:** The Lee County Sheriff's Office recommends executing the acceptance of the grant award.

- **9. Background:** Human Trafficking is a well defined and ongoing criminal activity affecting the quality of life in Lee County, Florida. Doug Molloy, Managing Assistant U.S. Attorney for the Middle District of Florida, has identified three types of trafficking in Lee County:
- Indentured Servitude: Use of trafficking victims in the agriculture industry;
- Sexual Slavery: Use of trafficking victims to service the migrant population and impoverished workers; and
- Domestic Servitude: Use of trafficking victims to work as homecare servants.

The Lee County Sheriff's Office (LCSO), in conjunction with the Lee County Board of Commissioners, federal, state and local law enforcement agencies, service providers, Immigrant Rights Advocacy Center, Inc., Zonta Club of Sanibel and several other community organizations, is working to eradicate Human Trafficking in our community.

In an effort to bolster resources to aggressively combat Human Trafficking in Lee County, the Lee County Sheriff's Office submitted a concept paper to the Bureau of Justice Assistance that was subsequently approved. The total grant award from the Bureau of Justice Assistance is \$450,000 and will be expended to the following areas:

Salaries: \$180,186.00; Benefits: \$62,064.00; Travel/Training: \$45,000.00; Equipment: \$66,000.00; Supplies: \$24,750.00; Contracts: \$72,000.00; LCSO Match: \$359,016.53. The match will be encumbered over the 3 year grant cycle with no fiscal impact during the first fiscal year except the in-kind match from the current salary of the project director.

The LCSO is one of ten law enforcement agencies throughout the country to receive this award.
