On June 12, 2001, the Board of County Commissioners entered into a Professional Services Agreement with BSSW, Inc. under CN-01-03 LEE COUNTY JUSTICE CENTER EXPANSION for an amount of \$76,103.00 (Phase I) with the understanding that future Phases for design, permitting and construction of selected options will be brought back to the Board for approval by change orders.

Change orders 1-22 have been previously approved and authorized in the amount of \$4,404,300.00.

SCOPE OF PROFESSIONAL SERVICES

for Lee County Justice Center Parking Structure

SECTION 1.00 CHANGE(S) TO PROFESSIONAL SERVICES

The "Scope of Professional Services" as set forth in Exhibit "A" of the Professional Services Agreement, or Service Provider Agreement, referred to hereinbefore is hereby supplemented, changed, or authorized, so that the CONSULTANT or SERVICE PROVIDER, shall provide and perform the following professional services, tasks, or work as a supplement to, change to, or authorized to, the scope of services previously agreed to and authorized:

I. Project Scope

The above referenced project is anticipated to consist of a 1,100 to 1,200 car parking structure located south of the Martin Luther King Jr. Blvd adjacent the existing justice center.

The following design criteria to be consider in the design:

- Parking Structure to be utilized by County and Justice Center employees as well as Public and Jury in support of the Justice complex.
- The Parking Structure to be designed to be expanded by future phases possibly bridging the existing secondary roads.
- Parking Structure to be designed to permit the future addition of a 80,000 110,000 GSF "Liner Structure" on MLK Blvd.

Project Budget is anticipated to be \$16,000,000 to \$17,000,000

The Schematic Design Documents shall include a conceptual site plan, preliminary building plans, sections and elevations. Preliminary selections on building systems either noted on drawings or in writing.
- 2.02 <u>Design Development</u> Based on approval of the Schematic Design Package and updated budget (Prepared by CM) the Design Development task shall define the refinement of the design of the project. Establish the scope, relationships, form, size and appearance of the project by means of plans, sections and elevations, typical construction details, and equipment layouts. The Construction Documents and Specifications that establishes in detail the quality levels of materials and systems required for the project.
- 2.04 <u>Bidding and Negotiation</u> BSSW Architects and their sub-consultants shall assist the Owner and Construction Manager in obtaining and evaluating bids from Sub-Contractors. Upon compellation of the sub-contractor bids by Construction Manager, the BSSW will assist County in evaluating the Final GMP package by the Construction Manager.

- 2.05 <u>Contract Administration</u> BSSW Architects and their sub-consultants shall provide administration of the Contract between the Owner and Construction Manager as follows:
 - Visit site at regular intervals (twice monthly) and advise Owner on progress of construction and adherence to contract documents.
 - Answer questions and issue, when appropriate, clarifications to the contract documents.
 - Review submittals of materials for compliance with contract documents.
 - Review and advise Owner on monthly applications of payment by Construction Manager.
 - Perform substantial and final completion inspections.
