#### 9. Background:

The Community Contribution Tax Credit Program provides incentives to encourage Florida businesses to make donations toward community development and low income housing projects. The businesses that make donations to approved organizations may receive a sales tax refund or tax credit equal to 50 percent of the value of the donation. Businesses may take the credit on their Florida corporate income, franchise, or insurance premium taxes.

The program requires that the local government issue a resolution stating the development activities of the organization are consistent with local plans and regulations. On March 31, 1998 the Board of County Commissioners issued a similar resolution to enable Habitat for Humanity of Lee County to receive donations.

# A RESOLUTION CERTIFYING THAT THE LEE COUNTY HOUSING DEVELOPMENT CORPORATION OPERATING IN UNINCORPORATED LEE COUNTY DOES SO IN A MANNER CONSISTENT WITH LOCAL LEE COUNTY PLANS AND REGULATIONS (INCLUDING THE COMPREHENSIVE PLAN)

WHEREAS, the Community Contribution Tax Credit Program of Florida provides an incentive to encourage Florida businesses to make donations toward community development and low income housing projects;

WHEREAS, businesses located in Florida that make donations to approved organizations may receive a sales tax refund or tax credit equal to 50 percent of the value of the donation and businesses may take the credit on Florida corporate income, franchise or insurance premium taxes;

WHEREAS, the Community Contribution Tax Credit Program set forth in the Florida Statutes (sections 212.08 (5) (p), 220.183 and 624.5105) requires that a resolution be passed by the local government certifying that the Lee County Housing Development Corporation is affiliated with economic/community development efforts in a manner consistent with local plans and regulations;

WHEREAS, it is necessary and in the public interest that Lee County certify that the Lee County Housing Development Corporation is building and developing affordable housing in a manner consistent with local plans and regulations (including the comprehensive plan)

## NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF LEE COUNTY, FLORIDA, THAT:

In the course of providing affordable housing to residents of Lee County the Lee County Housing Development Corporation complies with all local plans and regulations within the unincorporated areas of Lee County.

Lee County will file this resolution with the State of Florida, Executive Office of the Governor, Office of Tourism, Trade and Economic Development to enable the Lee County Housing Development Corporation to obtain approval under the Community Contribution Tax Credit Program.
