#### Lee County Board Of County Commissioners Agenda Item Summary Blue Sheet No. 20070479

#### **1. ACTION REQUESTED/PURPOSE:**

Award and authorize staff to enter into a Construction Manager Agreement for RFQ-06-12 CALOOSAHATCHEE CREEKS PRESERVE, to Karr Group, Inc., d/b/a Casey Construction for the sum of six and a half (6.5%) percent of the total construction cost of the project. Further approve the Guaranteed Maximum Price (GMP) in the amount of \$2,117,379.04 (includes Construction Manager (CM) fee of \$129,229.71). Also request Board approve waiving of any formal process (if needed) and authorize the use of the Direct Material Purchase Orders based on CM's Agreement which allows the County to purchase directly from suppliers of equipment and/or material as a cost/time saving measure. Authorize Chairman to execute the Construction Management agreement upon receipt. Approve Transfer of Funds from Reserves to Parks and Recreation Operations for the Caloosahatchee Creeks Preserve project in the amount of \$732,684.

## 2. FUNDING SOURCE:

**Fund** – Capital Improvement – Environmentally Sensitive Land; **Programs** – Florida Community Trust (FCT); Federal Grant through Florida Department of Environmental Protection (FDEP); Federal Grant through FDEP; Capital Improvement Program (CIP); and Parks and Recreation Operations, **Projects** – Caloosahatchee Creeks Preserve; Subsidiary – Caloosahatchee Creeks Preserve; Caloosahatchee Creeks Trails; Caloosahatchee Creeks Land and Water Conservation Fund (LWCF); County Wide New Boardwalks and Caloosahatchee Creeks Preserve.

## 3. WHAT ACTION ACCOMPLISHES:

Provides Construction Management services for the clearing and installation of driveways and parking areas, water retention areas, Clivus restrooms, picnic shelters, trails (no trail clearing), -2955 linear feet of boardwalks, 2316 linear feet of packed shell trail, kayak launch, picnic tables, signs, trash cans, bike racks, kiosks etc. In accordance with site plans, permits and grant requirements.

The deadline for receipt of the Qualification Submittals was October 18, 2006. A total of six (6) submittals were received by the established deadline date. All six (6) submittals were considered at the Qualification Selection Committee meeting held on October 25, 2006. The Qualification Selection Committee consisted of the following staff members: Jim Lavender, Director of Public Works, Chairman; Tom Easley, Construction & Design, Project Manager; and John Yarbrough, Parks & Recreation Director. Based on the information submitted by the Contractors in their Qualification Statements, it was the consensus of the Committee to invite three (3) firms for interviews/presentations.

After conducting the interviews/presentations with the three (3) "shortlisted" firms (Karr Group d/b/a Casey Construction, J.L. Wallace Inc., and Lodge Construction) on November 1, 2006, it was the consensus of the Committee to recommend award to Karr Group Inc., d/b/a Casey Construction.

It is being recommended that the Board approve a Construction Manager Agreement for the project known as RFQ-06-12 CALOOSAHATCHEE CREEKS PRESERVE, to Karr Group Inc., d/b/a Casey Construction, for a Construction Manager Fee of 6.5% (\$129,229.71) with a Guaranteed Maximum Price of \$2,117,379.04.

In order for the County to take advantage of saving the sales tax and as a time saving measure we are requesting authorization to purchase materials from various vendors selected by the construction manager and the County.
