
- Whereas: Three hundred Lee County abused, neglected or abandoned children currently in the Dependency system need their voices heard through a volunteer Guardian ad Litem (GAL) speaking for them in court and advocating for them in the community; and
- Whereas: The Lee County Guardian ad Litem Program has been dedicated to supporting volunteers who represent child victims since 1980, through a dedicated Lee County staff; and
- Whereas: Voices for Kids, a not-for-profit agency has had the important mission of supporting Guardian ad Litem volunteers in Lee, Collier, Charlotte, Hendry and Glades counties and the child victims in their cases, including a Children's Clothes Closet, Happier Birthday Program, Tutoring and Arts Programs, Behavioral Analysis Program aimed at maintaining the child where he or she lives, as well as providing funding for a child's individual special needs; and
- Whereas: Last year about 100 volunteers donated over 50,000 hours to be the voices in court and the advocates within the community for about 700 children in Lee County; and
- Whereas: Both Voices for Kids and the Guardian ad Litem Program participate locally and statewide in speaking to legislators and community leaders about abused, neglected, and abandoned children's needs, joining nationally with The Court Appointed Special Advocate Program.

NOW, THEREFORE BE IT RESOLVED by the Board of County Commissioners of Lee County, Florida that we do hereby proclaim April 24 – May 1, 2007 as:

Voices for Kids Week
