LEE COUNTY DIVISION OF PLANNING STAFF REPORT FOR INTER-LOCAL SERVICE-DELIVERY AGREEMENTS

STAFF REPORT PREPARATION DATE: October 20, 2005

PART I - BACKGROUND AND STATUTORY REQUIREMENT

1. In 1996, the Florida Legislature created The Commission on Local Government II, the purpose being to suggest statutory and constitutional changes concerning the powers, financing and service delivery capacity of local governments within Florida.

As a result the Legislature passed Chapter 2002-1996, Laws of Florida. The law created Sections 163.3177(6)(h) 6., and 8. The law mandates that counties having a population of over 100,000, and the municipalities and special districts within those counties submit a report that identifies all existing or proposed inter-local service delivery agreements regarding the following **eight community service areas**:

2. Guide Lines:

The Lee County Inter-local Agreement Report includes the following sections, in compliance with the statues. They are as follows:

- **A.** The report includes an inventory of the service providers in the county and existing agreements related to the eight service areas listed in the statutes.
- **B.** The report identifies unnecessary duplication and gaps/deficits in the existing service delivery arrangements.
- **C.** The report describes options to remedy the inefficiencies, in the delivery of public services.

3. Master List of Service Providers and Special Districts located in Lee County (Table 1).

Table 1 identifies each reporting entity and indicates whether the entity is a jurisdiction, dependent or an independent special district (column 2). The abbreviation and the name of the jurisdiction or special district are located in column three and four. **If a reporting entity is not a party to any of the eight categories of inter-local agreements listed in the statue, the table is marked with an "X" in the last column.** These would be special districts that had not been chartered with the responsibility to respond to the eight (8) categories that the Department of Community Affairs had generated.

Table 1 was generated utilizing information gathered from the Department of Community Affairs and the Lee County, County Attorney's Office. As required through Florida Statutes, Chapter 189 all Special Districts are required to submit information about their existence and responsibilities to the Department of Community Affairs. Florida Statute 190.006 also places requirements on the creation of a Community Development District after the ordinance to the local governing body has accepted the jurisdiction and responsibilities of the CDD.

4. Existing Service Delivery Arrangements

This report analyzed all Inter-Local Service Agreements Lee County had on file within the eight public services categories as indicated by the statutes, to the citizens of unincorporated Lee County, the Cities of Cape Coral, Fort Myers, Bonita Springs, Sanibel and the Town of Fort Myers Beach. If an Agreement was known to be in-active it was marked in the spreadsheet. (Note: There were over 800 agreements with 152 letters being sent out to each entity having an inter-local agreement with the county to determine the status of each agreement and there were only 65 responses). A list of the inter-local agreements for the specified agencies is provided in Table 2. As stipulated in the Guidelines for Preparing the Inter-local Service-Delivery Agreement Report, dated July 20, 2003, a special column titled Agreement No. has been incorporated in the report to identify the type of service in an abbreviated form along with a report number for this report. For the purposes of this report, the service area is comprised of the judicial boundaries of Lee County, the five (5) municipalities located within Lee County (Public Sector Service Providers), and the jurisdictional boundaries of the various Independent District Service Providers located within Lee County. A listing of the Public Sector Providers and Independent Service Providers (Table 1) is included above. In addition, inter-local service agreements have been prepared with surrounding counties, various state agencies, and organizations that do not represent a geographic region inside of Lee County.

5. Identify Duplication of Services

Part II of the report (Findings) identifies duplication of services and facilities. Duplication of service only occurs when two entities provide the same service within the same (over lapping) geographical area. Such duplication may relate to either (or both) capital costs of providing the service or to the operational costs of maintaining the service. If the geographic boundaries of a service cannot be determined from the agreements, then there exists a potential for overlap and, a potential for duplication of service delivery to exist.

Duplication of services through Inter-Local Agreements has not been a recurring problem for Lee County. In the cases it does happen, generally with infrastructure for water or sewer, no extensions of lines is proposed unless it would benefit the overall transmission network.

6. Identifying Service-Delivery Deficits

Service delivery deficiencies are addressed in Part III (Service Deficiencies) and listed in Table 3. The Inter-Local Agreement process is intended to address a recognized deficiency in service, either because the service is not able to be provided or because the expected level of service can not be achieved by Lee County; then have it responded to by another jurisdiction capable of providing such services. This process, by

definition is designed to seek out an agreement with a provider to remove a recognized deficiency with some sort of compensation. If an agreement cannot be reached, it is because the service is not fiscally viable for that location or the service is simply not available.

The Inter-Local Agreement process is not designed to identify service short-comings, it is designed to be a tool to address service deficits after they have been identified. However, as part of the requirements for the Inter-local Service Delivery Agreement Report, a general view of service deficiencies has been prepared.

7. Identify Needed Updates

Part IV summarizes the findings and identifies the need for specific actions to be taken or agreements to be updated or revoked.

PART II FINDINGS

Education (ED)

The education system, managed by the Lee County School District, includes public schools (grades K-12), adult education, and vocational training, but does not include charter or private schools. Inter-Local Agreements existing between the Lee County School Board and the Department of Parks and Recreation and Emergency Management allow resources and funding to be shared. The Department of Parks and Recreations has on-going inter-local agreements to allow neighborhood parks to be located on school district properties where applicable. Additionally, there are inter-local agreements with the Office of Emergency Management for Lee County to utilize school district facilities as shelters during times of emergency and to provide funding to upgrade school district facilities to meet Red Cross shelter requirements. Much of what is accomplished with these agreements limits itself to additional property uses that would maximize the use of publicly owned lands. The School District of Lee County has an on-going agreement with the Lee County Department of Community Development to assist in locating potential school sites, as well. This consists of locating parcels of land, of sufficient size to house a school facility that does not conflict the land use designations and fits in anticipated growth patterns for Lee County.



Sanitary Sewer (SS)

Sanitary Sewer Service includes all public or private wastewater treatment systems that adhere to an adopted level of service standard and concurrency requirements. Lee County Utilities (LCU) has jurisdiction to provide central wastewater service throughout the unincorporated Lee County to an area currently totaling approximately 94 square miles with a future service area anticipated to total 189 square miles. The limitation being the "Future Sanitary Sewer Service Area" boundary established in the Lee Plan (Map 7). The LCU's wastewater system consists of eight wastewater treatment plants servicing individual districts. LCU's service infrastructure, consist of approximately 489 miles of gravity sewer mains, 274 miles of force mains, 529 lift stations, and associated appurtenances. In addition, LCU owns and maintains two collection and transmission sewer systems that discharge to wastewater treatment plants owned by the City of Fort Myers. LCU pays the capacity through arrangements established in an inter-local agreement. Each of the eight wastewater treatment plants provides reclaimed water to bulk customers inside their service areas. Additionally, agreements exist with a multitude of smaller private systems, that to provide sanitary sewer to a specific sub-divisions not currently supplied by LCU. As LCU expands their capacity and infrastructure, it is intended these facilities will be bought by LCU.



D. Duplication of Services



Public Safety (PS)

Public Safety refers to all police, fire, emergency medical services, and emergency response services operating in Lee County. The only entities with countywide jurisdiction are Lee County EMS, Lee County Emergency Management Department, and the Lee County Sheriff's Office. The municipalities of Ft. Myers, Cape Coral, Sanibel, and the Town of Fort Myers Beach provide their own law enforcement and fire and rescue service along with 14 special districts, listed below. The special districts divide up the remaining county lands into response districts. Mutual Aid agreements, in the form of Inter-Local Agreements, exist between the primary providers to provide services in neighboring jurisdictions should the need arise. The secondary providers are entities involved in providing relief or shelter space during time of emergency or are special districts that respond to a different set of regulations. Inter-Local Agreements are also utilized as a primary method of distributing emergency response funds to be used within Lee County.





 The renewals or amendments for emergency response inter-locals, over time, have created a multitude of similar inter-locals covering the same area and responding to roughly the same criteria. These need to be reviewed with out-dated agreements removed.

Solid Waste (SW)

Lee County has chosen to privatize the primary methods of solid waste management: Collection, Disposal, and Processing. Local ordinances mandate that all residential and commercial entities be subject to solid waste collection within unincorporated Lee County. Solid waste for the unincorporated areas of Lee County are being collected by Onyx Waste and Florida Recycling Services, this is to change in 2005 to the following companies: Waste Management, Waste Pro (aka Florida Recycling Services), Waste Services, and Onyx Waste Services. These private companies have also contracted to collect solid waste from the City of Bonita Springs and the Town of Fort Myers Beach. The City of Fort Myers collects its solid waste for transfer to Lee County's mass burn facility. Solid waste from Gasparilla Island is collected by Waste Management and disposed of at the Charlotte County Landfill. Cape Coral has contracted with Waste Management and Sanibel has a contract with Florida Recycling Services for solid waste collection, inter-local agreements are in place with Lee County for the disposal of solid wastes.

Inter-local agreements exist between the municipalities within Lee County, Charlotte County, and Hendry County for disposal / recycling activities of collected refuse; contracts with the private companies are established for collection and management activities. Lee County solid waste transfer sites exist in Hendry County as does the Lee/Hendry County Landfill. In addition to this facility Lee County owns a mass burn facility capable of processing 600 tons of waste product per day (with a 600 ton/day expansion planned). Ash by-product and excess solid waste are transferred to the Lee/Hendry Landfill.

Recycling activities take place on the campus that houses the mass burn facility. Recycling activities range from horticulture by-product to plastics, paper, and glass. These facilities are managed via private contractors with inter-local agreements in place to accept refuse from surrounding municipalities.



Drainage (DR)

Drainage includes all natural or manmade systems that are subject to an adopted level of service standard. The responsibilities of the Primary Providers are to maintain drainage systems associated with county roadways and the drainage and detention / retention systems within Lee County. Lee County also maintains a database of natural flow-ways and works actively with developers to preserve the integrity of these flow-ways. Additionally, Lee County maintains the Six Mile Cypress Slough that presents several unique opportunities and challenges. Lee County Parks and Recreation maintains the Slough as a environmentally sensitive area for the public to view while Lee County DOT is responsible for maintaining the water level to ensure it's viability as a water detention / retention facility for the surrounding roadways. Inter-Local Agreements exist between various county departments and the surrounding municipalities to ensure the storm-water run-off is handled properly.



Potable Water (PW)

Potable Water includes all public or private systems that are subject to an adopted level of service standard. Lee County Utilities (LCU) has jurisdiction to provide potable water throughout unincorporated Lee County to an area of approximately 110 square miles with a future service area anticipated to be 185 square miles. Limitations of the jurisdiction are set by the "Future Water Service Areas" boundary established in the Lee Plan (Map 6). Roughly 1080 miles of waterline, six ground storage tanks, and two elevated storage tanks make up the bulk of the infrastructure for potable water distribution. The potable water system consists of 7 existing water treatment plants with an eighth plant nearing completion (late 2005). Inter-Local Agreements exist with the municipalities of Fort Myers and Cape Coral to provide connections that would allow each entity to provide potable water should the need arise.

LCU has acquired private utilities in the unincorporated Lee County as its service area has increased. However, in many cases the secondary providers maintain the infrastructure for a specific sub-division and contract purchase potable water in bulk from LCU for distribution. There is less concern in purchasing the infrastructure for potable water distribution as long as they agree to purchase water in bulk from LCU.



Parks and Recreation (PR)

Lee County Parks & Recreation Department provides and maintains community and regional parks, recreational services, boat access, programming for the general public and for those with specialized needs, recreational facilities and through agreements with private / not for profit organizations additional resources at specific parks.

Lee County maintains inter-local agreements with many of the municipalities within Lee County to maintain several of the larger recreational facilities located within their corporate limits.

In addition to the park facilities Lee County Parks and Recreation is responsible for the stewardship of approximately 4,500 acres of lands either set aside as preserve, conservation, or mitigation of damage to other lands. Much of this is done through cooperative (inter-local agreements) efforts with other public agencies or private / not for profit ventures.



Transportation Facilities

Transportation includes all public or private transit and transportation facilities and systems that are subject to an adopted level of service standard. The majority of the inter-local agreements deal with the transportation network for Lee County that has been constructed and maintained by the Lee County Department of Transportation. The division consists of Transportation Services Administration, the Transportation Planning Department, Traffic Operations, the Transportation Operations Development Review and Right of Way Permit Department, the Transportation Engineering and Construction Management Department, and the Lee County Road Maintenance Department. Transit services are provided by LeeTran who maintains the para-transit system for Lee County and acts as the transit authority for Lee County.

Inter-Local Agreements exist with all levels of governmental municipalities concerning maintenance of transportation network and ensuring connectivity to ensuring impact fees generated by development are adequately distributed to the proper governmental entity. As part of the transportation network, inter-local agreements exist with the surrounding municipalities for the maintenance and general up-keep of the traffic signal system. In addition to the inter-local agreements in place with the surrounding municipalities, Lee Department of Transportation also holds agreements with the surrounding counties and regional governmental entities such as the Metropolitan Planning Organizations adjacent to Lee County, to address issues such as connectivity.



Part III Service Delivery Deficits

The Inter-Local Agreement system in place for Lee County is a mechanism to address known deficiencies in either service or coverage. It would be a rare occurrence that an actual, physical area located within Lee County is not receiving services for any of the eight (8) categories designated in this report because of an over-sight or because this geographic area is not covered by some governmental jurisdiction. In cases where services are not currently being provided or a level of service is not being addressed, the responsible agencies have plans in place to provide coverage when it becomes fiscally viable. Coverage items such as sanitary sewer, solid waste, potable water, parks and recreation, and transportation are continually being reviewed by Lee County staff and the surrounding municipalities, in an attempt to provide the maximum coverage and a maintainable system.

In addition, certain categories such as potable water and sanitary sewer have jurisdictional limitations on services to be provided, by the Lee Plan to restrict development in predominately rural or protected areas (Map 6 & 7, Chap. IV of Lee Plan). Areas such as public safety have several different avenues of ensuring coverage and coordination with surrounding municipalities outside of the Inter-Local Agreement Process, however the use of the inter-local agreement still plays a prominent role in the cooperative efforts of law enforcement, fire, and rescue agencies within Lee County.

However, with the rapid growth of Lee County there are instances of development surpassing the ability of providing services. All categories have examples of unacceptable Levels of Service to geographical areas that cannot be met because of either fiscal or time constraints in building new facilities. Where applicable, these areas are being addressed through the Inter-Local Agreement process as well as other avenues. To satisfy the requirements of this report, the following table uses the eight (8) categories generated by the rules for this document to identify deficiencies. The listings are general in nature and not site specific but get to the direct problems being faced. Each category has existing inter-local agreements in place to address these broad based items.

Part IV. Identify Needed Updates

The Inter-Local Agreement process for Lee County works well with no need for changes to accomplish its objectives of ensuring public services are being provided to their greatest potential with a minimal amount of redundancy between governmental entities. However, one issue that this report has brought to light is the amount of coordination necessary to keep track of current inter-local agreements. As can be expected creating inter-local agreements to ensure public services for the geographic area of Lee County involves a multitude of municipalities. Not only are the number of players a problem but the process of adopting an inter-local agreement makes it difficult to track for several different reasons. One of these reasons is the creation or maintenance of an inter-local agreement does not fall under one governmental entity's jurisdictional responsibilities. As such, the creation of this report required considerable man-hours and involved personnel from a multitude of different agencies. To address this deficiency, the Planning Division of Lee County has worked with Lee County Clerk of Courts (responsible for maintaining minutes from County initiated public meetings) to create a process that will allow the Planning Division to better assist in tracking the inter-local agreements for the eight (8) listed categories.

The method will allow queries to gather detailed information of the inter-local agreement, the jurisdictions involved, and the duration of the agreement. The County Attorney's Office being the final point, to "flag" a draft inter-local agreement before going before the Board of County Commissioners for approval, would have a crucial role in supplying this information. Once the appropriate information has been included, the process to query an inter-local agreement is relatively simple. This step will streamline the efforts of maintaining an accurate list of current inter-local agreements for the eight (8) listed categories of interest.
