**SCOPE OF WORK:** Job will require a performance bond. Work to include extensive demolition to the existing structure using LEAD SAFE PRACTICES, Concrete footers, fill dirt with compaction testing and certification, concrete slab, CBS walls, Concrete tie beams, new roof trusses, framing carpentry labor, Roof dry in and overhead shingle covering, Electrical wiring both rough in and trim out including fixtures and ceiling fans, New electrical service, HVAC system including all new ductwork, rough and trim plumbing including all new drain and water lines, plumbing fixtures, water heater, insulation, Drywall, paint, windows, doors and trim, stucco, site work, ceramic tile, cabinets and countertops, carpeting, septic tank and drainfield.

Type of bids desired: Line Item Price

The contract will be awarded to the lowest responsible, reasonable, and responsive bidder subject to the County's right to reject any or all bids, and to waive any formalities in the bids or the bidding process with or without cause. Lee County will not be a party to the construction contract, unless the County owns property. **Any award will be contingent upon availability of funding from the Department of Housing and Urban Development through Lee County Human and Veteran Services.**

**NOTE:** Specifications will contain alternate items, which may or may not be awarded, depending on the total cost of the rehab work.

This meeting is for the purpose of allowing contractors to bring any omissions, alterations and/or recommendations concerning the *Schedule of Work* to the attention of Lee County Human and Veteran Services staff. This is an opportunity to make suggestions prior to bidding and failure to do so will demonstrate the contractor's acceptance of the *Scope of Work* as defined. Any addenda issued as a result of this meeting will be issued in writing within two (2) working days of the meeting. **IT IS MANDATORY THAT THE CONTRACTOR OR HIS REPRESENTATIVE ATTEND THIS PRE-BID MEETING. FAILURE TO ATTEND WILL RESULT IN FORFEITING THE RIGHT TO BID ON THIS PROJECT.**

**Bidders must submit all documents according to requirements contained in the *Instruction to Bidders*. Failure to comply with this requirement may result in the bid being considered non-responsive.**
