#### III. Board Membership – Erin Dalla Costa, LCSD "Project Access"

To prepare for the new school year, engagement has been done all summer with school social workers. So far, there are over 900 students identified as displaced in their housing.

# IV. Ratify Amendment to Written Standards on CoC Disaster Policies\*

CoC Disaster Policies were reviewed. Policy discusses how priorities would change in an event of a disaster. Policy makes ESG (Emergencies Solutions Grant) flexible and available to people who are working on FEMA Temporary shelter and FEMA direct housing. Motion to ratify Disaster Policies as is, with the understanding modifications can be made later.

**ACTION:** Michael Overway made a motion to ratify Written Standards on Disaster Policies as is. Barbara Short seconded the motion. Motion passed unanimously.

Changes to the Coordinated Entry Prioritization system, permanent supportive housing, and rapid rehousing criteria were proposed.

## Coordinated Entry Criteria Currently:

- Small section of direct referrals for High Need High Utilizer Task Force.
- Up to half of referrals come from the exception process; which is when an exception request is sent to Christopher Molloy in Coordinated Entry who can make an exception to send that person to Permanent Supportive Housing.
- The Other half are People who score an 8+ on the Vulnerability Assessment, Mental Health, Tri-Morbid (mental health, physical health, and substance abuse problem at same time), Chronically Homeless, Physical Health Issues, and Veterans.

#### New Changes that were proposed:

- Small section of direct referrals for High Need High Utilizer Task Force.
- About half of referrals come from the exception process
- About half 8+ on Vulnerability Assessment, mental health, Tri-Morbid (mental health, physical health, and substance abuse problem at same time), Chronically Homeless, lack self-care, over 60 years of age.

Lacking self-care is explained as having trouble taking care of daily needs; as an example, getting meals daily.

**ACTION:** Lue Richardson made a motion to add a point for Veterans in newly proposed changes to Coordinated Entry PSH written Standards. Linda Hafner seconded the motion. Motion passed unanimously.

#### Rapid Rehousing Criteria Currently:

- Small section of direct referrals for High Need High Utilizer Task Force.
- About a quarter of referrals come from the exception process who score above an 8.
- About a quarter from people who score an 8+ on Vulnerability Assessment, mental health, Tri-Morbid (mental health, physical health, and substance abuse problem at same time), Chronically Homeless, Physical Health Issues, and Veterans
- About a quarter from people who score a 7 or below, mental health, Tri-Morbid, Chronically Homeless, and Physical Health Issues
- About a quarter from people who score 7 and below and have exception letters

#### Rapid Rehousing New Criteria proposed:

- 1% of direct referrals for High Need High Utilizer Task Force
- 12% of referrals come from the exception process who score above an 8.
- 11% from people who score an 8+ on Vulnerability Assessment, mental health, Tri-Morbid, Chronically Homeless, Physical Health Issues, and Veterans
- 38% from people who score below a 7, Households with Children, households with individuals aged 60 and above, households who are fleeing domestic violence, and 1<sup>st</sup> time homeless households.

- 38% of people below 7 and exception letters
- Veterans also get a point in Rapid Rehousing Criteria

**ACTION:** Jessica Cosden made a motion to approve the prioritization for rapid rehousing and permanent supportive housing as amended adding a point for Veterans. Motion was seconded. Motion approved Unanimously.

#### VI. Amend CoC Written Standards on Rapid Rehousing Discharge Policies\* *Tim Gillmore*

Circumstances under which Rapid Rehousing programs can remove clients who were referred were reviewed.

**ACTION:** Alex Olivares made a motion to approve Amended Written Standards for Rapid Rehousing Discharge Policies. Terryn Baah-Achemfour seconded motion. Motion approved unanimously.

## VII. Explore VI-SPDAT Alternatives – Data Committee directive from Governing Board\* *Tim Gilmore*

**ACTION:** Michael Overway made a motion to direct Data Committee to find alternatives of VI-SPDAT over a six-month period. Linda Hafner seconded Motion. Motion passed unanimously.
