In accordance with U.S. Department of Housing and Urban Development (HUD) regulations governing Community Development Block Grant (CDBG), Emergency Solutions Grant (ESG), and HOME programs, Lee County hereby invites the public to review the draft Lee County Annual Action Plan for HUD Program Year 2018. The plan covers unincorporated Lee County, the Cities of Bonita Springs and Sanibel, and the Town of Fort Myers Beach. The goal of the plan is to provide affordable, decent housing, suitable living environments, and expanded economic opportunities for low to moderate-income persons.
