Whereas: They assist in sustaining the voluntary efforts of the community and the at-large businesses, professionals and government agents; and

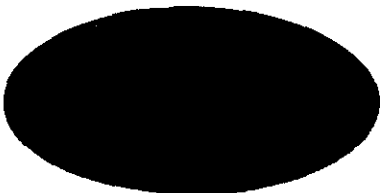
