8. Background:

Ordinance 90-03, the Lee County Water Shortage Plan, as amended by Ordinance 91-24, provides permanent water restrictions and prohibit restaurants from serving water unless requested by the customer. South Florida Water Management District has requested Lee County to implement a Water Shortage Plan and Mandatory Year-Round Landscape Irrigation Measures as written in Chapters 40E-21 and 40E-24, Florida Administrative Code.

Chapters 40E-21 and 40E-24, together with language prohibiting restaurants from serving water unless requested by the customer eliminates the need for Lee County Ordinance Nos. 90-3 and 91-24. If the "Lee County Water Conservation Ordinance" is adopted, Lee County Ordinance Nos. 90-3 and 91-24 will be redundant and should be repealed.
