**9. Background:**

In accordance with Lee County Ordinance, 04-18, the Enhanced 9-1-1 Telephone System Program Manager shall recommend approval for street name changes of existing plats within the unincorporated areas of Lee County. This request was made by the City of Bonita Springs Public Works Department in an effort to officially change a portion of a street being realigned within Bonita Springs city limits. This office has retained the responsibility of approving new streets/name changes and the assignment of addresses within the City of Bonita Springs since their incorporation.

This name change is the result of a realignment of the existing Pennsylvania Ave to join the existing section of Ragsdale St, west of Old 41 Road. There is one occupant to be affected by this name change.
