**2. Project Description:** (Include county, location with reference to range monuments, brief project history and description of proposed activities.):

The non-federal Lovers Key Restoration Project (R214.5-R220.5) was constructed in October 2004. The 1.1 mile beach and dune restoration project was completed on Lovers Key State Park and consisted of placing approximately 570,240 cy of material was taken from a borrow site in Big Carlos Pass ebb shoal complex. Lee County is the local sponsor working in cooperation with FDEP's Division of Recreation and Parks. Nourishment was completed in December 2014 in conjunction with the Bonita Beach project to the south. The project placed approximately 342,350 cy of material on Lover's Key. In anticipation of permit modifications supporting future nourishment, additional sand sources need to be identified.

## 3. Use of Requested Program Funds:

Professional services to locate, characterize, and quantify sand sources compatible for future nourishment and modify the existing permit accordingly.

WHEREAS, Lee County supports all components of the Budget Plan consistent with the Lee County Comprehensive Plan and agrees to fund the local government share of all County beach and inlet projects approved for funding by the Florida Legislature in Fiscal Year 2018-2019 through the existing dedicated bed tax revenues, special taxing units, or other funding resources as applicable, and
