

# Lee County Parks & Recreation parking sticker or pool passport application form

Parking sticker or pool pass purchasing procedure

- Complete areas 1,2 and 4 to purchase a parking sticker
- Complete areas 1,3 and 4 to purchase a pool pass
- Return completed application with payment using a method located at bottom of page

Pool passport program allows pass holders to use any pool operated by Lee County Parks & Recreation during regular operating hours.

Parking sticker program allows you to park free at the following locations: Bonita Beach accesses 1 & 10 (not Bonita Beach Park), Bowman's Beach, Bunche Beach, Turner Beach (north lot only), Bowditch Point Regional Park, Caloosahatchee Regional Park, Caloosahatchee Creeks Preserve, Six Mile Cypress Slough Preserve, Manatee Park, Lakes Regional Park and Hickey's Creek Mitigation Park. Parking stickers are also valid at boat ramps: Alva, Davis, Imperial River, Matlacha and Punta Rassa. Parking sticker is also valid at Pine Island Commercial Marina on weekends and county-recognized holidays. NOTE: Please circle the parking facility above that will be your primary use. This is for statistical purposes only and does not limit your use of other facilities.
