TITLE: Award Contracts for Minor Paving, Drainage and Concrete Improvements - Countywide

I. MOTION REQUESTED

- A) Award Invitation to Bid No. B180007ANB Annual Contract For County-Wide Minor Paving, Drainage & Concrete Improvements to the following contractors for a period of one year to provide minor paving, drainage and concrete improvements, as approved in the departments' annual adopted budgets: Ajax Paving Industries of Florida LLC; Bonness Inc.; Boyd Irrigation, Inc.; Clary's Sitework & Development, Inc.; Coastal Concrete Products, LLC dba Coastal Site Development; Community Asphalt Corp.; Denco Construction, Inc.; JRL Underground Utilities, Inc.; Pavement Maintenance, LLC; Preferred Materials, Inc.; Southern Striping Solutions, LLC; Stevens & Layton, Inc.; Thompkins Contracting, Inc.; Tomahawk Construction LLC.
- B) Authorize County Manager or designee to approve individual projects over \$50,000 and up to \$500,000, projects over \$500,000 will be subject to a separate sealed bid process.
- C) Authorize Chair to execute contracts on behalf of the Board upon receipt.
- D) Grant the Director of Procurement Management the authority to negotiate renewals of the contracts, including changes in price, for up to one additional one-year period, and/or to extend the contracts, and to execute all associated documents, with County Administration approval, as approved in the departments' annual adopted budgets, if doing so is in the best interest of Lee County.

II. ITEM SUMMARY

Awards contracts to fourteen contractors for minor paving, drainage and concrete improvements on an as needed basis for one year with the option to renew for one additional one-year period, as approved in the departments' annual adopted budgets: Ajax Paving Industries of Florida LLC; Bonness Inc.; Boyd Irrigation, Inc.; Clary's Sitework & Development, Inc.; Coastal Concrete Products, LLC dba Coastal Site Development; Community Asphalt Corp.; Denco Construction, Inc.; JRL Underground Utilities, Inc.; Pavement Maintenance, LLC; Preferred Materials, Inc.; Southern Striping Solutions, LLC; Stevens & Layton, Inc.; Thompkins Contracting, Inc.; Tomahawk Construction LLC. Total expenditures for these services for Fiscal Year 2016-2017 were approximately \$2,514,887.34.

III. BACKGROUND AND IMPLICATIONS OF ACTION

A) Board Action and Other History

The Department of Transportation submitted a request to Procurement Management to obtain bids for the countywide minor paving, drainage and concrete improvements. On March 9, 2018, Procurement Management advertised B180007ANB Annual County-Wide Minor Paving, Drainage & Concrete Improvements. On the bidding deadline of April 13, 2018 Procurement Management received fourteen bids. All bids have been reviewed by the Department of Transportation and it is recommended that award be made to all fourteen responsive, responsible bidders meeting all bid requirements based upon unit price.

The County will issue a Notice to Proceed on individual projects with any or all of the bidders, with consideration of availability and lowest unit prices for that type of work. Payment and Performance Bonds will be required on all individual projects estimated at \$100,000 or more. Projects with estimated construction costs of \$500,000 or more will be competitively bid.

The purpose of this contract is to provide several departments the ability to have contractors they can call upon to complete minor projects without having to go through the formal bidding process for each project. Funds have been budgeted in several projects in the FY 2018/19 budgets.

Total expenditures for these services for Fiscal Year 2016-2017 were approximately \$2,514,887.34.
