- C) Grant the Director of Procurement Management the authority to renegotiate and execute renewals of these contracts for up to three additional one-year periods, under the same terms and conditions, if doing so is in the best interest of Lee County.
- D) Authorize the Procurement Director to approve the application of the price escalation/de-escalation clause, as provided in the contracts, during the term of the contract and any contract renewals.

WHAT ACTION ACCOMPLISHES:

Approves a one-year contract for the annual Countywide purchase of automotive and equipment batteries on an as-needed basis from NAPA J&K Auto Parts and Batteries By Fisher, Inc. via Bid No. B-160212. Provides two sources for batteries used in the County's fleet of vehicles and equipment. Countywide, the FY 2014-2015 expenditure for automotive and equipment batteries was \$72,123.01.

Background:

Lee County Fleet Management, Solid Waste and Transit Departments require a variety of batteries to keep their vehicles and equipment operational. Procurement Management advertised Invitation to Bid No. B-160212/PTL for Automotive and Equipment Batteries on May 13, 2016. On the established deadline of June 3, 2016, Procurement received five bid responses. The bids received were thoroughly reviewed resulting in a recommendation of award to the two bidders offering the highest percentage off of original equipment manufacturer (OEM) list price, NAPA J&K Auto Parts and Batteries By Fisher, Inc., for the purchase of batteries on an as-needed basis.
