 Award Contracts for the Purchase of Fuel - Countywide

I. MOTION REQUESTED

A) Award Invitation to Bid No. B180281TJM Annual Fuel Purchase to the following vendors for a period of one year, as approved in the departments' annual adopted budgets: Southern Petroleum Resources, LLC – primary vendor category A; Palmdale Oil Company, Inc. – secondary vendor category A and primary vendor for categories B, C, D, E; Mansfield Oil Company of Gainesville, Inc. – tertiary vendor for category A.

B) Authorize the Chair to execute the contract documents on behalf of the Board of County Commissioners.

C) Grant the Director of Procurement Management the authority to approve or deny vendor requests for markup rate increases, to add or delete additional locations/delivery sites and fuel types as needed at a negotiated markup rate, and to remove non-performing vendors and adjust primary, secondary, and tertiary awards accordingly.

D) Authorize the Director of Procurement Management to execute contract amendments for price changes, the addition/deletion of fuel types, and locations and vendor awards as necessary.

E) Grant the Director of Procurement Management the authority to negotiate renewals of the contracts, including changes in price, for up to three additional one-year periods, and/or to extend the contracts, and to execute all associated documents, with County Administration approval, as approved in the departments' annual adopted budgets, if doing so is in the best interest of Lee County.

II. ITEM SUMMARY

Awards contracts for purchase of fuel countywide to the following vendors: Southern Petroleum Resources, LLC as the primary vendor for category A; Palmdale Oil Company, Inc. as the secondary vendor for category A and the primary vendor for categories B, C, D, and E; Mansfield Oil Company of Gainesville, Inc. as the tertiary vendor for category A, for an initial period of one year with the option to renew for three additional one-year periods, as approved in the departments' annual adopted budgets. Total expenditures for these goods and services during Fiscal Year 2016-2017 were approximately \$3,601,053.14. The County departments that purchase fuel under the annual contract are Transit (LeeTran), Fleet Management, Solid Waste, Utilities, Facilities and Construction Management, Public Safety, Department of Transportation and Natural Resources.

To verify fair and reasonable fuel pricing, Lee County uses the Oil Price Information Service (OPIS), a company that offers price transparency across the global fuel supply chain. Vendors providing fuel to the County charge a fixed markup over the OPIS average Tampa, Florida price per gallon as reported by OPIS through a daily report for Unleaded 87 and 89 Octane, and #2 Ultra Low Sulfur Diesel Clear and #2 Ultra Low Sulfur Diesel Dyed fuel. Using OPIS fuel price benchmarks as the base price for fuel purchasing supports the County's efforts to ensure the best price in real time without the need to process contract amendments or change orders.

III. BACKGROUND AND IMPLICATIONS OF ACTION

A) Board Action and Other History

On Friday, June 15, 2018, Procurement Management advertised Invitation to Bid No. B180281TJM Annual Fuel Purchase on behalf of the Board of County Commissioners. On the bidding deadline of July 16, 2018, Procurement received five bids. After conducting an analysis on the bid submissions, staff recommends making an award for primary vendor (lowest responsive bid), secondary vendor (next lowest responsive bid) and a tertiary vendor (third lowest responsive bid) as applicable for each category as listed below:
