Award Annual Contract for Construction Manager at Risk

I. MOTION REQUESTED

A) Award Request for Proposal No. CMR180033TJM Construction Manager at Risk – Annual Contract to the following 15 vendors for use on an as needed basis for management of construction projects throughout the County, with a total cost less than \$2,000,000.00 per project, for an initial period of two years, as approved in the departments' annual adopted budgets; individual projects with a cost of \$100,000.00 or more shall be brought back to the Board for approval: AIM Construction Contracting, LLC; Brooks & Freund, LLC; Chris-Tel Company of Southwest Florida, Inc.; Fowler Construction and Development Inc.; Garney Companies, Inc.; Gates Butz Institutional Construction, LLC; Gilbane Building Company; Manhattan Construction (Florida), Inc.; O-A-K/Florida, Inc. dba Owen-Ames-Kimball Company; Stevens Construction, Inc.; Stultz, Inc.; Target Builders Construction Management, Inc.; Westco Builders of Florida, Inc.; Wharton-Smith, Inc.; and Wright Construction Group, Inc. B) Grant the Director of Procurement Management the authority to negotiate renewals of the contract for up to three additional one-year periods, and/or to extend the contract, and to execute all associated documents, with County Administration approval, as approved in the departments' annual adopted budgets, if doing so is in the best interest of Lee County.

II. ITEM SUMMARY

Approves award of the annual contract for Construction Manager at Risk (CMAR) services to a pool of 15 firms for management of construction projects with a total cost less than \$2,000,000 per project throughout the County. Services will be used on an as needed basis for an initial period of two years. Individual projects shall be awarded to firms based on experience, availability and license(s) in accordance with Florida Statute. Individual projects with a total cost over \$100,000 will be brought back to the Board for approval. Total expenditures for these services during Fiscal Year 2016-2017 were approximately \$1,867,618.45.

III. BACKGROUND AND IMPLICATIONS OF ACTION

A) Board Action and Other History

Procurement Management advertised Construction Manager at Risk (CMAR) Request for Proposal No. CMR180033TJM Construction Manager at Risk – Annual Contract on December 29, 2017. On the proposal deadline of January 29, 2018, Procurement received 15 proposals. The Evaluation Committee ranked the proposals on February 22, 2018 and decided to proceed with presentations from all 15 firms. After presentations on February 27, 2018, the Evaluation Committee recommends award to the following 15 firms: AIM Construction Contracting, LLC; Brooks & Freund, LLC; Chris-Tel Company of Southwest Florida, Inc.; Fowler Construction and Development Inc.; Garney Companies, Inc.; Gates Butz Institutional Construction, LLC; Gilbane Building Company; Manhattan Construction (Florida), Inc.; O-A-K/Florida, Inc. dba Owen-Ames-Kimball Company; Stevens Construction, Inc.; Stultz, Inc.; Target Builders Construction Management, Inc.; Westco Builders of Florida, Inc.; Wharton-Smith, Inc.; and Wright Construction Group, Inc.
