Award Contracts for Plumbing, HVAC and Electrical Engineering Services - Countywide

### MOTION REQUESTED

A) Award Competitive Negotiation Request for Proposal No. CN180582TJM, Plumbing, HVAC and Electrical Engineering Services -Annual, to the following vendors for an initial period of two years, to provide professional consulting services, as approved in the departments' annual adopted budgets: Diversified Technology Consultants, Inc.; McKim & Creed, Inc.; OCI Associates, Inc. and TLC Engineering Solutions, Inc. dba TLC Engineering for Architecture. Individual projects with a cost of \$100,000.00 or more shall be brought back to the Board for approval.

- B) Authorize the Chair to execute the contract documents on behalf of the Board of County Commissioners.
- C) Authorize the County Manager or designee to approve individual projects over \$50,000 and up to \$100,000 on behalf of the Board of County Commissioners.
- D) Grant the County Manager or designee the authority to negotiate renewals of the contracts, including changes in price, for up to three additional one-year periods, and/or to extend the contracts up to six months, and to execute all associated documents, with County Administration approval, as approved by the departments' annual adopted budgets, if doing so is in the best interest of the County.

## II.

Awards contracts for plumbing, HVAC, and electrical engineering services to provide professional consulting services, on an as needed basis, for an initial period of two years, with the option to renew for three additional one-year periods, to Diversified Technology Consultants, Inc.; McKim & Creed, Inc.; OCI Associates, Inc. and TLC Engineering Solutions, Inc. dba TLC Engineering for Architecture. Total expenditures for these services during Fiscal Year 2017-2018 were approximately \$78,742.75.

### III. BACKGROUND AND IMPLICATIONS OF ACTION

A) Board Action and Other History

> On October 19, 2018, Procurement Management issued Competitive Negotiation Request for Proposal No. CN180582TJM, Plumbing, HVAC and Electrical Engineering Services - Annual. On the proposal deadline of November 19, 2018, Procurement Management received five proposals.

> The Competitive Negotiation Evaluation Committee's first evaluation meeting was held on December 11, 2018, during which the committee considered criterion listed in the solicitation: Qualifications of the Firm/Company Relevant Experience; Plan of Approach; References and Personnel. All five firms were short-listed to return for interviews. Interviews were conducted on January 4, 2018. Following the interviews, the final committee meeting was held. The committee recommended awarding contracts to four of the five firms: Diversified Technology Consultants, Inc.; McKim & Creed, Inc.; OCI Associates, Inc. and TLC Engineering Solutions, Inc. dba TLC Engineering for Architecture.
