TITLE:

Approve annual purchase of Cisco hardware, support and maintenance through State Term Contract

ACTION REQUESTED:

- A) Approve the ability to utilize pricing on existing Florida State Term Contract for the annual purchase of standardized Cisco hardware, support and maintenance Countywide on an as-needed basis as approved in the departments' annual adopted budgets.
- B) Authorize use of Florida State Term Contract No. 43220000-WSCA-14-ACS through its expiration date of May 30, 2019 and any contract extensions approved by the State.
- C) Authorize the Chair to execute any required contract documents on behalf of the Board of County Commissioners associated with the purchases.

FUNDING:

As approved in the departments' annual adopted budgets.

WHAT ACTION ACCOMPLISHES:

Authorizes annual purchase of standardized Cisco hardware, support and maintenance on an as-needed basis in support of enterprise-wide computer hardware, networking equipment, and services through Florida State Term Contract. Purchases can be made from Cisco Systems, Inc. or any of the authorized partners listed on the State Contract. The contract will be available for use Countywide, as approved in the departments' annual approved budgets, through its expiration date of May 30, 2019 and through any contract extensions approved by the State. While spending varies year-to-year, Fiscal Year 2015/2016 spend for these services was approximately \$610,000 for Cisco equipment.

Background:

Several years ago, Lee County decided to standardize its computer network hardware with Cisco products. Since then, this standardization was implemented on an enterprise-wide basis and Cisco equipment continues to be installed in new and upgraded facilities as needed. This is a significant investment, which also requires the annual purchase of support and maintenance.

On August 17, 2016, Procurement received a request from Information Technology Group (ITG) to obtain Board approval to purchase Cisco hardware, support and maintenance for Countywide use via Florida State Contract No. 43220000-WSCA-14-ACS Piggyback No. PB160570). Use of the State Contract allows the County to purchase Cisco products from any of the vendors under the contract.
