

FIRST AMENDMENT OF AGREEMENT FOR ENVIRONMENTAL
MAINTENANCE (EXOTIC PLANT CONTROL)

THIS FIRST AMENDMENT OF THE AGREEMENT FOR ENVIRONMENTAL MAINTENANCE (EXOTIC PLANT CONTROL), made and entered into on this 3 day of August, 2018 by and between the Lee County Board of County Commissioners, a political subdivision of the State of Florida ("County") and SOLitude Lake Management, LLC, a Virginia limited liability company authorized to do business in the state of Florida, ("Vendor"), collectively, the "Parties."

WHEREAS, the County entered into an Agreement for the purchase of environmental maintenance services, Contract Number 7526, through Solicitation Number RFP160333DK with Vendor on the 27th day of September, 2016 ("Agreement"); and,

WHEREAS, on the date the Agreement was executed, the Vendor's business entity name was; Lake Masters, LLC; and,

WHEREAS, on January 1, 2018, the Vendor's consolidation was effected and Lake Masters, LLC was consolidated with the limited liability company SOLitude Lake Management, LLC, with a Federal Tax ID Number of 54-1940110; and

WHEREAS, County and Vendor desire to enter into this First Amendment to continue their Agreement under Contract Number 7526 under the Vendor's new business entity name; and,

WHEREAS, the County has modified its award procedures for the types of services performed under this Agreement and will be utilizing a new simplified form; and,

WHEREAS, the Parties desire to update the Agreement with the correct form terminology pursuant to Article XIV. MISCELLANEOUS of the Agreement.

NOW, THEREFORE, IN CONSIDERATION OF THE FOREGOING AND THE MUTUAL COVENANTS CONTAINED HEREIN, IT IS AGREED AS FOLLOWS:

1. Vendor, conducting business as SOLitude Lake Management, LLC, shall continue to supply such commodity or service in accordance with the terms, conditions, and specifications of Solicitation Number RFP160333DK and Contract Number 7526, including appendices, amendments, and Vendor's response.
2. All uses of the term: "Supplemental Task Authorization" shall be superseded by: "County Project Authorization."
3. All uses of the term: "Change Order" shall be superseded by: "County Project Modification."
