Award Request for Proposal No. RFP160553DKR, Fencing Services for Lee County, to the following vendors for new fence installation, fence repair, and gate installation and repair on an as needed basis for a period of one year as approved by the departments' annual adopted budgets: Century Fence Company, Inc.; Smith Fence Co. of Fort Myers, Inc.; Walker Exotic Tree Eradication & Mitigation LLC; Ronald A. Beecroft, Inc.; and Backwoods Clearing & Services Inc.

- B. Authorize the Chair to execute the contract documents on behalf of the Board of County Commissioners.
- C. Grant the Director of Procurement Management the authority to negotiate renewals of the contracts, including changes in price, and to execute renewal documents for up to three additional one-year periods, with County Administration approval, as approved in the departments' annual adopted budgets, if doing so is in the best interest of Lee County.

Awards Request for Proposal No. RFP160553KR, Fencing Services for Lee County, to five vendors for new fence installation, fence repair, and gate installation and repair on an as needed basis for an initial period of one year. Expenditures for these services totaled approximately \$670,591 during Fiscal Year 2015-2016.
