WHEREAS, the Parties desire to make certain amendments to the Agreement in accordance with Section 39. MODIFICATION of the Agreement; and,

WHEREAS, the Contractor and its parent company desire to continue providing all required collection services in accordance with the terms and conditions of the Agreement and all amendments thereto.

NOW, THEREFORE, IN CONSIDERATION OF THE FOREGOING AND THE MUTUAL COVENANTS CONTAINED HEREIN, THE PARTIES AGREE TO AMEND THE AGREEMENT AS FOLLOWS:

Under Section 6. CHARGES, RATES, PAYMENTS, DISPUTES, AND
 INTEREST RATES, the reporting of the monthly Franchise Fees as set forth in the fourth paragraph of E. Franchise Fee is replaced with the following:
 For Service Area One (1), the monthly Franchise Fees in the amount of 5.5% will be reported in three (3) separate statements, one for the incorporated areas

of the City of Bonita Springs, one for the incorporated area of the Town of Fort Myers Beach, and one for the incorporated areas of the Village of Estero, for invoiced amounts arising from the services and operations conducted within each boundary.

2. All other terms and conditions of the Agreement and all amendments thereto remain in full force and effect.
