TITLE: Extend Annual Contract for Granular Activated Carbon and Adsorption/Filtration Services

I. MOTION REQUESTED

A. Approve amendment to the annual contract with Calgon Carbon Corporation, for Granular Activated Carbon (GAC) and Adsorption/Filtration Services, to allow for one additional six-month period through February 13, 2019, for the purchase of granular activated carbon and absorption/filtration services, as approved in the department's annual adopted budget.

B. Authorize the Director of Procurement Management or designee to sign the extension documents on behalf of the Board of County Commissioners.

II. ITEM SUMMARY

Approve amendment of the annual contract with Calgon Carbon Corporation, to allow for one additional six-month period through February 13, 2019, for granular activated carbon and adsorption/filtration services for Lee County Utilities. Board approval will allow for the purchasing of these goods to continue uninterrupted until the formal solicitation process is completed. Total annual expenditures are approximately \$168,000.

III. BACKGROUND AND IMPLICATIONS OF ACTION

A) Board Action and Other History

On August 8, 2013, the Board of County Commissioners awarded Request for Proposal No. RFP130426 for the purchase of granular activated carbon and adsorption/filtration services. The original term of the contract was for one-year with an option to renew for four additional one-year periods through August 12, 2018. Board approval will allow for an additional six-month extension, through February 13, 2018, so that the purchase of these goods will continue uninterrupted until the formal solicitation process is completed.

Total annual expenditures for these goods are approximately \$168,000.00.
