TITLE: Award Contract for Hydrogeologic Consulting Support Services

I. MOTION REQUESTED

A) Award Competitive Negotiation No. CN170311ANB Hydrogeologic Consulting Support Services to the following firms to provide professional engineering and design services on an as needed basis for a period of two years as approved in the departments' annual adopted budgets: Johnson Engineering, Inc., RMA GeoLogic Consultants, Inc., Stantec Consulting Services Inc., Water Science Associates, Inc., and WSP USA Inc.

B) Authorize the Chair to execute the contract documents on behalf of the Board of County Commissioners.

C) Grant the Director of Procurement Management the authority to negotiate renewals of the contracts, including changes in price, and to execute renewal documents for up to one additional one-year period, with County Administration approval, as approved in the departments' annual adopted budgets, if doing so is in the best interest of Lee County.

II. ITEM SUMMARY

Award Competitive Negotiation No. CN170311ANB Hydrogeologic Consulting Support Services to the following firms to provide professional geology and hydrogeological services, including but not limited to Deep Injection Well Permitting and Mechanical Integrity Testing, Water Use Permitting, well maintenance and groundwater modeling, on an as needed basis for an initial period of two years: Johnson Engineering, Inc., RMA GeoLogic Consultants, Inc., Stantec Consulting Services Inc., Water Science Associates, Inc., and WSP USA Inc. Total expenditures for these services under the previous contracts, from 07/2014 to 12/2017, were approximately \$1,029,432.

III. BACKGROUND AND IMPLICATIONS OF ACTION

A) Board Action and Other History

The Utilities Department submitted a request to Procurement Management to obtain proposals for the project known as CN170311ANB Hydrogeologic Consulting Support Services for general hydrogeologic services on an as needed basis. On the proposal deadline of April 24, 2017, the Procurement Management Department received seven proposals.

At the Competitive Negotiations Committee meeting held on June 16, 2017, all letters of interest were considered. Each member indicated who they considered the most qualified and why. The committee members scored the vendors on experience with aquifer storage and recovery, experience with deep injection wells, experience with production wells, experience with hydrogeologic testing, investigation, modeling and analysis, key personnel qualifications and experience and general approach.

Presentations by the proponents were organized by Procurement Management and held on September 28, 2017. The committee recommended award to Johnson Engineering, Inc., RMA GeoLogic Consultants, Inc., Stantec Consulting Services Inc., Water Science Associates, Inc., and WSP USA Inc. Services to be provided under the agreements include hydrogeologic technical studies and reports; permit application preparation and permitting support; data compilation, review, analysis, groundwater modeling and assessment; design, plans and technical specifications; well contractor management and observation; and hydrogeologic field investigation and testing.
