

FIRST AMENDMENT OF AGREEMENT FOR LUBRICANT PRODUCTS

THIS FIRST AMENDMENT OF THE AGREEMENT FOR LUBRICANT PRODUCTS, made and entered into on this 8 day of August, 2018 by and between the Lee County Board of County Commissioners, a political subdivision of the State of Florida ("County") and Edison Oil Company, Inc. ("Vendor"), collectively, the "Parties."

WHEREAS, the County entered into an Agreement for the purchase of lubricant products through Solicitation B170172TJM with Vendor on the 11th day of October, 2017 ("Agreement"); and,

WHEREAS, the Parties mutually agree to increase the price for several lubricant products and acknowledge the effect this will have on Vendor's primary and secondary vendor status; and,

WHEREAS, the Parties desire to modify the Agreement pursuant to Article XV. MISCELLANEOUS of the Agreement.

NOW, THEREFORE, IN CONSIDERATION OF THE FOREGOING AND THE MUTUAL COVENANTS CONTAINED HEREIN, IT IS AGREED AS FOLLOWS:

1. The Parties agree that the following Category 4: High Temperature Grease table shall supersede the existing Category 4: High Temperature Grease table in Exhibit B of the Agreement, with Vendor remaining as the primary vendor:
