## FIRST AMENDMENT OF AGREEMENT FOR LUBRICANT PRODUCTS

THIS FIRST AMENDMENT OF THE AGREEMENT FOR LUBRICANT PRODUCTS, made and entered into on this 8 day of August, 2018 by and between the Lee County Board of County Commissioners, a political subdivision of the State of Florida ("County") and Palmdale Oil Company, Inc.
