



DeLa here is the cost increase for raw timber(wood fiber) 2014 -2015 from Lykes Brothers Inc. our primary wood supplier for Slash Pine and Eucalyptus tree species. This increase is far greater % than was passed on to Collier County whose mulch type uses primarily pine wood in manufacturing of product used. Please note, Forestry Resources requests that this information remain confidential understanding it has provided said documentation specifically at the request of Collier County.

Thank you, Lissett.

Mr. Olinger,

I'm happy to help you. Just a few questions for you to get an idea of how your operation is supplied:

1. Forestry Resources does procure it's raw materials locally from developers, real estate projects, mitigation

projects, etc., correct? Currently Forestry Resources primarily obtains raw material (wood fiber) from contracts with large landowners and timber harvesting company's. We do also utilize the same from developers, real estate and mitigation but this overall percentage is much smaller portion than what is commercially harvested. Wood cost has increased from \$31.00 to \$35.00 @ \$4.00 per ton Impact of that increase is @ \$0.074 on a 2 cu ft. bag and \$0.111 on a 3 cu ft.

- What about your plastics supplier (for bagged mulch)?
 Plans to up upgrade bag line to fully automated will negate need to carry duplicate inventory of open top bags price should be stable.
- Are your pallets supplied, or built in-house?
 Pallets are both purchased and reconditioned here on site. Blended costs has increased from \$3.50 to \$4.50 for Pallets are both purchased and reconditioned here on site. Blended costs has increased from \$3.50 to \$4.50 for 4 way mulch pallets. This equates to @ \$0.02 cost per bag!
- 4. What about chemicals cost related to mulch treatment? Supplier(s) of dyes for mulch color variance? Larger bulk purchases of colorant and greater efficiencies recognized will maintain costs!
