## 1. ACTION REQUESTED/PURPOSE:

# 10. Background:

On February 25, 2012, the Division of Procurement Management received a request from Lee County Utilities to waive the formal quotation procedure to allow for the purchase of Neptune Water Meters and Parts from Sunstate Meter and Supply Inc. This waiver is requested because the vendor is the sole authorized Neptune Distributor with a resell supply agreement in the State of Florida.

Water meters are a necessary device utilized to measure water usage and subsequently bill customers for water and/or wastewater service. Newly constructed homes and commercial businesses require a water meter to begin to be billed for utility service. Water meters for existing customers can be damaged, become scratched, stuck and aged over time. These meters require replacement to maintain the accuracy of water usage measurement and accuracy of billing for water and/or wastewater service. Wastewater service is based upon water usage. Meter replacements and repairs are part of ongoing maintenance and included in operating budges annually.
