This is needed to accommodate the increase in usage due to an increase in the number of repairs required by an aging building infrastructure and a growth in the amount of square footage in the buildings Countywide.

On September 10, 2014, the Division of Procurement Management as part of its on-going contract monitoring function became aware that the Board approved annual amount of \$120,000 under Formal Quote No. Q-120212 – The Annual Purchase of Plumbing Supplies would not be sufficient to cover the County's expenditures for plumbing supplies for the fiscal year. Projected future usage indicated that an increase to \$200,000 annually would be required. Unfortunately due to the costly repairs this wasn't enough. Now we are asking to go from \$200,000 to \$300,000 to help maintain our buildings. Facilities attributes this increase to a combination of an increased number of repairs required by an aging building infrastructure and a growth in the amount of square footage in buildings County-wide.
