TITLE: Award Contracts for Custodial Services for Lee County Central Zone

I. **MOTION REQUESTED**

A) Award Request for Proposal No. RFP180119MRH, Custodial Services for Lee County Central Zone, to the following vendors to provide custodial services to County facilities located in the Central Zone, for an initial period of one year, as approved in the departments' adopted budgets: American Facility Services, Inc.; At Your Service, Inc.; and United States Service Industries, Inc.

B) Authorize the Chair to execute the contract documents on behalf of the Board of County Commissioners.

C) Grant the Director of Procurement Management the authority to negotiate renewals of the contracts, including changes in price, for up to three additional one-year periods, and/or to extend the contracts and to execute all associated documents, with County Administration approval, as approved in the departments' annual adopted budgets, if doing so is in the best interest of Lee County.

II. **ITEM SUMMARY**

Awards contracts for custodial services in the Lee County Central Zone for an initial period of one year with the option to renew for three additional one-year periods to: American Facility Services, Inc.; At Your Service, Inc.; and United States Service Industries, Inc. Total expenditures for these services during Fiscal Year 2016 -2017 were approximately \$540,049.52.

III. **BACKGROUND AND IMPLICATIONS OF ACTION**

A) **Board Action and Other History**

On February 13, 2018, the Department of Procurement Management advertised RFP180119MRH Custodial Services for Lee County Central Zone to obtain proposals for custodial services for county facilities located within the central zone on behalf of the Board of County Commissioners. On the proposal deadline of April 13, 2018, Procurement Management received five proposals. An evaluation meeting was conducted on May 14, 2018, during which the Evaluation Committee considered criterion as listed in the solicitation request, including such items as: firm history, qualifications, experience, plan of approach, references and personnel. After evaluating the proposals submitted by the firms, it was the consensus of the committee to recommend the top three qualified firms for the second evaluation phase. Those firms were: American Facility Services, Inc., At Your Service, Inc., and United States Service Industries, Inc. The committee recommended each facility be awarded to the qualified firm that supplied the lowest pricing at each location. Total expenditures for these services for Fiscal Year 2016 - 2017 were approximately \$540.049.52.
