

FIRST AMENDMENT OF THE AGREEMENT FOR  
CUSTODIAL SERVICES FOR LEE COUNTY SOUTH ZONE

THIS FIRST AMENDMENT OF THE AGREEMENT FOR CUSTODIAL SERVICES FOR LEE COUNTY SOUTH ZONE, made and entered into by and between the Lee County Board of County Commissioners, a political subdivision of the State of Florida ("County") and United States Service Industries, Inc. ("Vendor"), collectively, the "Parties."

WHEREAS, the County entered into an Agreement for the purchase of custodial services for Lee County South Zone through Solicitation No. RFP180122MRH with Vendor on the 6<sup>th</sup> day of November, 2018 ("Agreement"); and,

WHEREAS, it was discovered after the execution of the Agreement that it would be in the best interest of the County for an additional location to be added; and,

WHEREAS, pursuant to Article V. ADDITIONAL PURCHASES, the Parties desire to modify Exhibit A to add one additional location to the Scope of Services; and,

WHEREAS, pursuant to Article XIV. MISCELLANEOUS of the Agreement, the Parties desire to add an additional location and accompanying pricing to the Exhibit B, Fee Schedule.

NOW, THEREFORE, IN CONSIDERATION OF THE FOREGOING AND THE MUTUAL COVENANTS CONTAINED HEREIN, IT IS AGREED AS FOLLOWS:

1. The Parties agree that the following location is added to the Exhibit A, Scope of Services, section titled "County Facilities Included Under This Agreement":

"FLEET MANAGEMENT, LEE COUNTY SHERIFF'S OFFICE

Location: 6035 Landing View Road

Fort Myers, FL

Cleaning shall be performed on a once a week basis.

Weekly tasks:

Sweep & mop vinyl flooring

Vacuum throw rugs

Wipe down counters & desks

Clean windows & doors

Empty trash & paper shredders

Clean Restrooms - 2

- Clean basins with detergent/disinfectant.
- Clean toilets and urinals using detergent/disinfectant.
- Damp wipe all ledges.
- Clean mirrors, soap dispensers, wash basin and all plumbing fixtures.
- Clean under basins, around toilets and urinals.
- Damp wipe walls, light switches and doors.
- Re-supply soap, toilet tissue, paper towels, personal seat covers, sanitary napkin liners, sanitary napkins, etc. (only anti-bacterial soap will be acceptable). Keep at least one extra toilet paper in each stall.
- Wet mop floors using detergent/disinfectant.”

2. The Parties agree that the following line is added to Exhibit B, Fee Schedule:


