

FIRST AMENDMENT OF AGREEMENT FOR ROW MOWING  
 FOR DOT AREAS 1, 2, 3, 4, 5, 6 AND 7

THIS FIRST AMENDMENT OF THE AGREEMENT FOR ROW MOWING FOR DOT AREAS 1, 2, 3, 4, 5, 6 AND 7, made and entered into on this 1 day of July, 2018 by and between the Lee County Board of County Commissioners, a political subdivision of the State of Florida ("County") and JSM Services, Inc. ("Vendor"), collectively, the "Parties."

WHEREAS, the County entered into an Agreement for the purchase of row mowing for DOT through Solicitation B170233KLC with Vendor on the 18<sup>th</sup> day of January, 2018 ("Agreement"); and,

WHEREAS, there are multiple vendors performing row mowing services through Solicitation B170233KLC and one of those vendors can no longer perform the services; and,

WHEREAS, the Parties desire to transfer the services from the vendor that is unable to perform them to the Vendor pursuant to Article XVI. MISCELLANEOUS of the Agreement.

NOW, THEREFORE, IN CONSIDERATION OF THE FOREGOING AND THE MUTUAL COVENANTS CONTAINED HEREIN, IT IS AGREED AS FOLLOWS:

1. The Parties agree that the following median and roadside landscape mowing area and accompanying detail shall be added to the Exhibit A Scope of Services:

Area 6	Lee County maintained roads between the Caloosahatchee and the County Line between I-75 East Limit to US 41 West excluding San Carlos Park Area between Alico Rd. and Estero Parkway.

2. The Parties agree that the following landscape maintenance sections and accompanying pricing shall be added to the Exhibit B Fee Schedule:






