

FIRST AMENDMENT OF AGREEMENT FOR
ANNUAL PURCHASE OF SOD COUNTYWIDE

THIS FIRST AMENDMENT OF THE AGREEMENT FOR ANNUAL PURCHASE OF SOD COUNTYWIDE, made and entered into on this 8 day of June, 2018 by and between the Lee County Board of County Commissioners, a political subdivision of the State of Florida ("County") and Battista Farms LLC ("Vendor"), collectively, the "Parties."

WHEREAS, the County entered into an Agreement for the purchase of sod, hydroseeding, pallet deposit, watering of sod and rolling of the sod through Solicitation B170047KLC with Vendor on the 3rd day of February, 2017 ("Agreement"); and,

WHEREAS, the Parties mutually agree to increase the price for several sod products; and,

WHEREAS, the Parties desire to modify the Agreement pursuant to Article XV. MISCELLANEOUS of the Agreement.

NOW, THEREFORE, IN CONSIDERATION OF THE FOREGOING AND THE MUTUAL COVENANTS CONTAINED HEREIN, IT IS AGREED AS FOLLOWS:


