II. ITEM SUMMARY

Approve extensions of the annual contracts with Siteone Landscape Supply, LLC and Florida Irrigation Supply, Inc. (dba FIS Outdoor) for an additional six-month period through December 30, 2018. Board approval will allow the purchasing of these goods to continue uninterrupted until the formal solicitation process is completed. Total expenditures for these goods during Fiscal Year 2016-2017 was approximately \$159,686.48.
