#### Local Technology Planning Team (LTPT) Goals:

- Work with Federal, State, and Local agencies to assess high-speed internet service needs in the community
- Locate residents and businesses that do not have access to high-speed internet services
- Work with County departments and County agencies to develop programs that address digital equity, literacy, telehealth, and workforce development; and that are eligible for grant funding
- Build partnerships with internet service providers to:
  - Reduce barriers to the deployment of highspeed internet services in the community
  - Provide high-speed internet services to unserved areas of the community


Responses received from July 1st, 2022 – August 1st, 2022





### LTPT – Total Broadband Investment in Lee County



# What Grant Opportunities are Next?

#### **Broadband Equity, Access, and Deployment (BEAD):**

- \$1.1 Billion allocated to Florida.
- For ISPs such as Comcast and Lumen to complete delivery of broadband services to unserved residences in Lee County.
- Evaluating the number of residences in need of broadband and sharing this data with the ISPs.
- This grant is likely to be issued in two parts, with the first wave of applications accepted during the 4<sup>th</sup> Qtr of 2024 and the second wave of applications accepted during the 3<sup>rd</sup> Qtr of 2025.

### <u>Digital Equity, Adoption, and Use – 'Capacity' Program (from State):</u>

- Florida will allocate a total of \$75M over the next couple of years for this grant.
- These grants will focus on digital navigator programs that support computers, tablets, wi-fi, computer labs, digital skills training and support services.
- Prime candidates for this grant are Libraries, Community Centers, and Non-profits such as Goodwill, United Way, and Boys & Girls Clubs.
- Phase I in late 2024 (\$40M) and Phase II in late 2025 (\$35M)

### <u>Digital Equity, Adoption, and Use – 'Competitive' Program (from NTIA):</u>

- Similar goals as the 'Capacity' grant above but will award from a \$1.25B bucket that will be administered by the NTIA.
- These grants will begin after the 1<sup>st</sup> Phase of the 'Capacity' grants, most likely starting in early 2025. Two phases are expected, to incentivize specific types of solutions and use cases. Phase I in Winter 2024/Spring 2025 and Phase II in Winter 2025/Spring 2026.
- Key eligibility factors will focus on digital navigator programs that support computers, tablets, wi-fi, computer labs, digital
  skills training and support services. Larger projects that require building construction and/or fiber optic networks between
  strategic sites will also be eligible.

#### **BEAD Preparation:**

- Work with ISPs and the State's Office of Broadband to identify remaining unserved/underserved residences. Lee County GIS has been very helpful in this area.
- The initial Gap Analysis showed 24,500 residents without access to hi-speed internet services. After factoring in the ISPs existing project build-outs that have since been completed, and the BOP and CPF BIP grant funds awarded to ISPs to service unserved areas, the current estimate is that ~8,900 residences remain unserved.

#### **Digital Equity, Adoption, and Use Grant Preparation:**

• Work with Lee County's Human & Veteran Services, Libraries, and Parks & Rec Departments, Lee Health, Goodwill, and United Way to identify digital needs of the populations served and to develop potential grant fundable project applications for submission. Project focus will be on affordable Internet Access, New and Re-purposed Devices, Skills Training, Digital Navigator and Virtual Support Options, and expansion of the developing Ecosystem of Support Resources.
