

As a follow up to our phone conversation last week, I am providing you with written clarification as to the status of Age Link. On April 19, 2002 the Age Link Board signed a Memo of Understanding with United Way. This agreement states that Age Link will dissolve as an agency effective June 30, 2002. Beginning July 1, 2002 United Way will become the Information and Referral service provider for Lee County. We are currently working on our 2001 audit and will provide that information to you as soon as it is complete. We will also have our auditor provide you with a copy of his final report, which will include the period of January through June 2002.

I hope this provides the clarification needed and I look forward to seeing you on May 23<sup>rd</sup> for our monitoring.
