The Lee County Housing Development Corporation (LCHDC) is a non-profit organization dedicated to providing affordable housing in Southwest Florida. During 1999 the Lee County Affordable Housing Committee recommended and the Board of County Commissioners approved (Nov 16, 1999) awarding the LCHDC a total of \$1.2 million in SHIP funds over a three-year period for the construction of 60 affordable housing units with a total project cost of \$6,705,887.

The total SHIP award for year 2 of the three-year project is \$444,424. The terms of the award are spelled out in grant award agreement C-1830, which expires in December 31, 2002. The LCHDC is requesting an extension of this deadline to May 30, 2003 because the LCHDC encountered minor delays during the negotiations with the utility company to provide water and sewer services to the subject lots.

Staff recommends that this extension be granted because: 1) it is in compliance with the SHIP rules and regulations and 2) it will ensure a timely completion of this project and fulfillment of the terms of the grant award agreement.

No additional SHIP dollars are required above those already granted.


