
1. <u>REQUESTED MOTION</u>:

<u>ACTION REQUESTED</u>: Approve and execute the Proposal and Quote in the amount of \$1,105,484.00 from Seminole Gulf Railway LP for rehabilitation and widening of the Alico Road Crossing #3 and the removal and replacement of track necessary to facilitate installation of two box culverts within the Alico Road Conveyance Ditch.

<u>WHY ACTION IS NECESSARY</u>: The Board of County Commissioners must approve expenditures in excess of \$50,000.00.

WHAT ACTION ACCOMPLISHES: Allows for the reconstruction of Crossing #3 on Alico Road and upsizing of box culverts under the railroad siding that crosses the Alico Road Conveyance Ditch in accordance with the "Alico Road No. 3 Easement Agreement" and the Alico Road construction plans.

REMOVAL AND REPLACEMENT OF NECESSARY TRACK AND ROADBED TO FACILITATE INSTALLATION OF 2 BOX CULVERTS

UNDER THE TERMS OF THIS PROPOSAL, SEMINOLE GULF RAILWAY SHALL FURNISH ALL RAIL RELATED MATERIAL, LABOR, AND EQUIPMENT FOR THE ABOVE-MENTIONED PORTIONS OF THE ALICO ROAD WIDENING PROJECT. SEMINOLE GULF RAILWAY SHALL ALSO FURNISH ALL RAIL RELATED SIGNAL, HIGHWAY GRADE CROSSING, AND TRACK SURFACE, ENGI-NEERING AND DESIGN. LEE COUNTY SHALL FURNISH AND INSTALL ALL PIPELINE AND DRAIN-AGE MATERIAL, M.O.T. AND ROADWAY SURFACE INSTALLATION TO SGLR AND AREMA SPECIFI-CATIONS ON RAILROAD PROPERTY. THE COUNTY SHALL ALSO FURNISH ALL OTHER ROADWAY RELATED CONSTRUCTION, DRAINAGE AND APPURTANCES.

PROPOSAL AND QUOTE

LEE COUNTY ALICO ROAD WIDENING PROJECT

TERMS OF PROPOSAL:

Seminole Gulf Railway shall provide all Rail related Labor, Equipment, Material, Engineering and Design for the following:

PHASE 1:

Open sidetrack at Schwab Switch for storage of Railroad surfacing machines and equipment. Stage Railroad construction material and equipment near the construction site at or near Alico road Crossing # 3.

Commence construction on one half of new Alico Road Crossing on North side of existing roadway. Install sub-surface, align, surface track, and install new highway grade crossing surface. Surface and align track to the north and east through the existing F.P.& L. Crossing to facilitate the transition into the new Alico # 3 Crossing. This will require the removal, replacement and resurfacing of the existing F.P.& L. Crossing.

Removal and replacement of the track, Railroad road bed and switch at the J.J. Taylor siding to allow Lee County's contractor to install 2 box culverts at that location.

END OF PHASE 1.

<u>**PHASE 2:**</u>

After Lee County closes the existing Alico Road, Railroad will commence construction of the new Alico Road Crossing on south side. The existing roadway through the railroad crossing will be removed. Railroad will install subsurface, install new track and Highway Grade Crossing surface, and surface and align track to the south and west through the existing Alico Center Road Crossing to facilitate the transition into the new Alico # 3 Crossing. This will require the removal, replacement and resurfacing of the existing Alico Center Road Crossing.

Railroad will remove existing highway grade Crossing warning devices at Alico # 3 Crossing and relocate them to Alico Center Road Crossing. Railroad will install new Highway Grade Crossing Warning Devices at the new Alico # 3 Crossing. All Signals will be tested and placed in service.

END OF PHASE 2.

The installation of the box culvert as mentioned above (see phase 1) shall be governed by the terms of this proposal.

The installation widening and construction of Alico # 3 Highway Grade Crossing as provided for in this proposal shall be governed by the terms of the Agreement dated September 14, 1988 where applicable.

The County's responsibilities within the right-of-way of the Railroad, during phase 1 and phase 2 as mentioned above shall include, but are not limited to: all maintenance of traffic, road closures and openings, poured concrete Crossing surface interfacing as required, road paving, marking, berms, medians, curbs, gutters, sidewalks, curb cuts, etc. County shall also provide all drainage and landscaping outside of the Railroad Crossing area as needed. The County shall supply labor, equipment and materials including necessary fill material for the installation of the two culverts under the J. J. Taylor siding. The County shall furnish a certified Law Enforcement Officer to protect Railroad employees while road closures are in effect.

The Railroad's responsibilities include supervision and inspection of all work performed within the Railroad right-of-way, and is limited to Railroad related construction with the exception of actual Highway Grade Crossing surface installations. The Railroad shall also be responsible for the removal and replacement of the track structure, switch and Railroad roadbed to allow for the County's contractor to install the two culverts under the J. J. Taylor siding.

All work performed within the right-of-way of the Railroad shall be performed under the direct supervision of a qualified Railroad Inspector. All methods and materials of construction for any work performed within the right-of-way of the Railroad shall be approved by the Seminole Gulf Railway Vice President of Construction and Maintenance and meet ~Association of American Railroads " standards and shall comply with ~American Railway Engineering and Maintenance-of-Way Association " (AREMA) standards. Work performed by others such as paving and poured concrete crossing interface installation shall meet or exceed manufacturer's specifications for its intended purpose.
